SAUDI ARABIAHani el-Sayegh

Hani el-Sayegh was handed over to the government of Saudi Arabia by the US authorities on 11 October 1999. He was arrested immediately on arrival, and his whereabouts are now unknown. Amnesty International is concerned that he is at risk of torture, and at risk of execution after an unfair trial.

The Saudi Arabian government intend to try Hani el-Sayegh for his alleged involvement in the bombing of a US military complex at al-Khobar in June 1996, which led to the deaths of 19 US servicemen. Such a crime carries the death penalty in Saudi Arabia.

The Saudi Minister of the Interior, Prince Naif bin 'Abdul-'Aziz, reportedly stated that "Hani el-Sayegh was handed over to us on Monday, and we appreciate the favourable response to our request from the United States." He added that Hani el-Sayegh was now "in the hands of Saudi justice" and would be interrogated and tried.

The US government claimed that it had received assurances from the Saudi Arabian government that Hani el-Sayegh would not be tortured, but they did not give details.

Amnesty International's concern that Hani el-Sayegh may not receive a fair trial and may face execution is heightened by a statement made by the Saudi Arabian Ambassador to the US, Prince Bandar bin Sultan bin 'Abdul-'Aziz, who was quoted by Agence France Pressed today as saying, "Hani el-Sayegh will not be questioned or tried in a different manner from that which is applied in Saudi Arabia." Trials in Saudi Arabia, which have been monitored over the years by Amnesty International and other human rights organizations, have fallen far short of international standards, particularly Article 10 of the Universal Declaration of Human Rights, which states: "Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any criminal charge against him." Trials, particularly of political suspects, are routinely held behind closed doors; defendants are denied legal representation and meaningful appeals against convictions, even in capital cases.

Amnesty International is planning to send a delegation to observe the trial of Hani el-Sayegh, and has informed the Saudi Arabian ambassador in London of its intentions.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- expressing concern that Hani el-Sayegh may be at risk of torture in incommunicado detention;
- reminding the Saudi Arabian authorities of their obligations under the Convention against Torture and Other Cruel, Inhuman and Degrading Treatment or Punishment to protect Hani el-Sayegh from torture;
- demanding assurances that Hani el-Sayegh's right to a fair and open trial will be respected and the trial will be open to international observers;

- seeking assurances that Hani el-Sayegh will be immediately given access to his family, lawyers of his choice and any medical attention he may need; - seeking assurances that if convicted, Hani el-Sayegh will not be sentenced to death.
