UA 253/00 Fear of Torture/Possible Prisoner of Conscience

SAUDI ARABIASheikh 'Ali bin 'Ali al-Ghanim

Sheikh 'Ali bin 'Ali al-Ghanim was arrested on 11 August 2000 at the al-Haditha check point on the border between Saudi Arabia and Jordan. The exact reason for his arrest is not known, but may be related to his Shi'a religious beliefs or activities. Amnesty International fears that Sheikh al-Ghanim may be at risk of torture.

At the time of his arrest, the 39-year-old Saudi Arabian father of five was returning to Saudi Arabia after a holiday in Syria. Prior to his arrest, he was reportedly summoned to the headquarters of the *al-Mabahith al-'Amma* (General Investigations), who are accountable to the Minister of the Interior, and asked to write a detailed report, particularly about the countries he has visited and suspected political opponents he may have known.

Two days later his house was searched. He is currently held in the al-Mabahith al-'Amma prison in the town of Dammam and has not been allowed any visits since his arrest. He is said to suffer from back problems.

Sheikh al-Ghanim returned to Saudi Arabia from exile in 1993 following the agreement reached between Shi'a groups and the government, which granted amnesty to Shi'a prisoners of conscience and political prisoners, and allowed many Shi'a political opponents living abroad to return home.

BACKGROUND INFORMATION

Widespread arbitrary arrest and detention of Shi'a Muslims or political opponents continues in Saudi Arabia. Fear of prosecution prevents members of the Shi'a religion from practising their faith freely.

Individuals suspected of political or religious dissent often risk arbitrary arrest and indefinite detention without charge or trial. Such detainees are regularly subjected to torture or ill-treatment. In the rare instances when they are charged and bought to trial, the proceedings invariably fail to meet the most elementary standards of fairness.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in or your own language:

- seeking assurances that Sheikh al-Ghanim is treated humanely, protected from torture and given access to family, lawyers and medical attention;
- requesting information regarding his arrest, including the reason for this and whether he has been charged with a criminal offence;
- expressing concern that he may have been arrested solely for the peaceful expression of his religious or political beliefs, and, in that case, calling for his immediate and unconditional release as a prisoner of conscience.
