SAUDI ARABIABangladeshi man, name unknown

A Bangladeshi man has reportedly been arrested for strangling three Saudi Arabian women during a series of robberies. Amnesty International is concerned that he may face the death penalty.

He stands accused of strangling three women, aged 18, 75 and 85, before making off with their jewellery and money. He was reportedly arrested in the village of Zahban, in the Red Sea province of Jeddah, after trying to strangle two other women.

It is very unusual for Amnesty International to receive information about such a case in Saudi Arabia before the sentence is carried out.

Saudi Arabia applies the death penalty for a wide range of offences. As well as violent crimes, these include some with no lethal consequences, such as sorcery and drug offences.

Amnesty International recognizes the right and responsibility of all governments to bring to justice those guilty of recognizably criminal offences. However, the organization is fundamentally opposed to the death penalty, as the ultimate violation of the right to life, as enshrined in Article 3 of the Universal Declaration of Human Rights.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic or your own language:

- seeking information about the exact charges brought against the Bangladeshi national reportedly arrested in Zahban and his whereabouts;

- seeking assurances that he is being treated humanely and that he will not face the death penalty;

- urging that he be allowed immediate and regular access to a lawyer, his family and an independent doctor;

- urging that he be given a prompt and fair trial in accordance with international standards;

- acknowledging the Saudi Arabian government's right to bring to justice anyone found responsible for recognizably criminal offences, but expressing your unconditional opposition to the death penalty in all cases as a violation of the right to life.
