SAUDI ARABIASheikh 'Ali bin 'Ali al-Ghanim

Sheikh 'Ali bin 'Ali al-Ghanim has reportedly been sentenced to five years' imprisonment. He may be at risk of torture or ill-treatment. Amnesty International is concerned that he may have been convicted on the basis of activities relating to his Shi'a religious beliefs, and if so would consider him a prisoner of conscience.

His trial was held in secret and no information is available as to the exact charges against him.

Sheikh 'Ali bin 'Ali al-Ghanim was arrested on 11 August, on Saudi Arabia's border with Jordan, at the al-Haditha checkpoint.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in English, Arabic or in your own language:

- asking for details of the trial proceedings and charges against Sheikh 'Ali bin 'Ali al-Ghanim;
- expressing concern that he may be a prisoner of conscience, in which case he should be released immediately and unconditionally;
- seeking assurances that he is being treated humanely, protected from torture and given regular access to his family, lawyers and any medical attention he needs.
