Amnesty International is concerned that the above five people were executed on 20 May 1993. The organization is further concerned that they were executed less than two months after the criminal incident for which they were convicted had taken place. It is feared that the speed with which this ultimate punishment was passed and carried out may have undermined the additional guarantees and safeguards required by international standards in death penalty cases. The organization is seeking clarification of the trial procedures and the processes of appeal and ratification of the sentences followed in the case of the five victims.

The five men named above, all common law prisoners, were found guilty of setting fire to al-Hasaka Prison on 24 March 1993, causing the death of 57 inmates and injuries to other prisoners. Two other defendants were sentenced to life imprisonment and a juvenile aged 17 received a 12-year prison sentence. Five prison guards were also reported to have been sentenced to three years' imprisonment apparently for being involved in drug corruption with the prisoners prior to the fire incident.

Amnesty International opposes the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading punishment, as proclaimed in the Universal Declaration of Human Rights.

- seeking details about the trial procedures, appeal, and ratification of the sentences followed in this case;
- urging commutation of any outstanding death sentences.
