## ***MEDICAL LETTER WRITING ACTION***

**Dr Ahmad Hamad  
SYRIA / LEBANON**

### **Keywords**

Theme: 'disappearance'

Affiliation: doctor

### **Summary**

Amnesty International remains concerned about the safety of Dr Ahmad Hamad, a Lebanese doctor, who was reportedly abducted on 18 or 19 June 1997 in Akkar, Lebanon. AI is concerned that he may be held by Syrian forces and is urging that his whereabouts be disclosed, his security be guaranteed and that he be freed unless he is to be charged with a recognisable crime.

### **Recommended Actions**

Letters are requested from medical professionals to the addresses below:

o calling for the disclosure of the whereabouts of Ahmad Hamad as a matter of urgency;

o seeking assurances that he is being treated humanely, and urging that he be allowed immediate and continuing access to his family and a lawyer of his choice

o seeking information about his state of health; urging that he be given access to a doctor and any medical care that may be necessary

o calling for his immediate and unconditional release or for him to be promptly charged with a recognized criminal offence and given a fair trial in accordance with international standards

**'DISAPPEARANCE'**

**Dr Ahmad Hamad

Ahmad Hamad, aged 37, a married Lebanese medical doctor and a member of the Lebanese Medical Association, remains unaccounted for, more than four months after his reported abduction in June 1997. There remains serious concern for his safety.

Dr Hamad was abducted on 18 or 19 June 1997 in Akkar, North Lebanon. It is believed that he was arrested by members of the Syrian military intelligence and initially held incommunicado at their headquarters in Halba, North Lebanon. His arrest is thought to relate to his alleged membership of an outlawed political party in Lebanon, the pro-Iraqi Ba'ath Party.

Amnesty International is concerned that he may have been taken to Syria where he could face ill-treatment and torture. Amnesty International is urging the Syrian authorities to account for his whereabouts and to ensure his safe return to his family unless he is to be charged and tried for a recognisable crime, in which case his whereabouts should be made public and he should be given access to his family, a lawyer and a doctor.

**Background**

Amnesty International has previously received reports that detainees held at the detention facilities of the Syrian military intelligence in Lebanon have been subjected to ill-treatment, including beating and kicking. They are often then transferred to Syria for interrogation. Amnesty International has also received reports of the torture of detainees from Lebanese and Arab prisoners transferred to Syria.
