The fate and whereabouts of three Libyan nationals remain unknown since their arrest by the UAE authorities. Amnesty International is concerned that should the three be forcibly returned to Libya they would be at risk of serious human rights violations.

On 3 July 2001, Ahmad Mohammad 'Ali 'Ak'ak was arrested at his home by members of *Amn al-Dawla* (State Security) in the Emirate of al-Sharjah. The reasons for his arrest are not known and nothing has been heard of him since.

Before his arrest, Ahmad Mohammad 'Ali 'Ak'ak worked as an *Imam* (religious leader) at al-Bayhaqi Mosque and as an accountant for a local company. He escaped from Libya in 1989 to avoid arrest because of his anti-government political and religious activities. He went to Saudi Arabia, Jordan and then to the UAE in September 1997. Ahmad Mohammad 'Ali 'Ak'ak is married and has three children.

'Ali Bashir, a father of eight children, was also said to have been arrested on 3 July while 'Ali 'Amish was reportedly arrested around May 2001. Amnesty International does not have any further information about 'Ali Bashir and 'Ali 'Amish

BACKGROUND INFORMATION

Amnesty International is concerned that an increasing number of Libyan nationals have been forcibly returned, or are at imminent risk of deportation, from various countries. Several suspected opponents of the Libyan government, especially members of or sympathizers with Islamist groups, were forcibly returned to Libya during 2000. Several people who had been forcibly returned to Libya have reportedly been tortured and killed by the security forces.

In April 2001, the UAE authorities summarily deported Jaweed al-Ghossein, a Palestinian national, to the Palestinian Authority. He had not been informed that he was to be deported and had no opportunity to challenge his deportation order

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Arabic or your own language:

- requesting clarification of the reasons for the arrest and detention of Ahmad Mohammad 'Ali 'Ak'ak, 'Ali Bashir and 'Ali 'Amish;
- requesting that they be given access to relatives, lawyers of their own choosing and medical care as necessary;
- urging their immediate release if they are not to be charged with a recognizable criminal offence;
- urging that Ahmad Mohammad 'Ali 'Ak'ak, 'Ali Bashir and 'Ali 'Amish should not be forcibly returned to Libya.
