Amnesty International deeply regrets the execution of Noureddine Rahmoun and Ahmed Fodhil on 11 January 1992. The two men, both military personnel, were sentenced to death in May 1992 by the military court in Blida for participating in an attack on the <a href="Mairauté">Amirauté</a> (Navy headquarters) in Algiers in February 1992. The death sentences were confirmed by the Supreme Court in October 1992. The case of Sid Ahmed Lahrani, who was also sentenced to death in absentia at the same time, appears not to have been reviewed yet by the Supreme Court.

Under Algerian law, those convicted by the military court may apply to the Supreme Court for review by cassation, a procedure which concerns only alleged misapplication of the law, not facts. If the death sentences are upheld by the Supreme Court, executions may only be carried out after a plea for clemency has been presented to the President of the Republic and refused.

These are the first executions known to have been carried out in Algeria since 1989. Forty-eight death sentences have been imposed over the last year, bringing the number of those said now to be on death row to over 120.

Amnesty International recognises the right of governments to bring to justice and to punish those responsible for criminal offences such as those mentioned above but opposes the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment. and punishment, as proclaimed by the Universal Declaration of Human Rights.

- expressing deep regret at the execution of Noureddine Rahmoune and Ahmed Fodhil;
- expressing regret that, with these executions, Algeria has carried out its first death penalty of over three years;
- reiterating that Amnesty International unconditionally opposes the death penalty in all cases as the ultimate form of cruel, inhuman or degrading treatment;
- urging that all death sentences be commuted and that steps be taken towards the abolition of the death penalty in Algeria.
