Further information on UA 97/00 (MDE 28/06/00, 26 April 2000) - Prolonged secret detention/fear of ill-treatment/health concern

ALGERIAEL Hadj M'lik

Amnesty International has just received reports that El Hadj M'lik, whose whereabouts had been unknown since his arrest more than ten months ago, has recently been seen alive in a military security centre in Ben Aknoun near the capital, Algiers. He is reportedly in poor health. His situation has been exacerbated by his advanced age and the fact that like other detainees, he is forced to sleep directly on a concrete surface without bedcovers.

El Hadj M'lik, who is in his 70s, was arrested by the security forces at his home in central Algiers on 14 April 2000 (not 13 April, as initially thought). He has been held in secret detention ever since. The authorities have denied all knowledge of his arrest.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in or in your own language:

- expressing concern about the prison conditions in which $El\ Hadj\ M'lik$ is held, stressing the health risks for someone of his advanced age;
- expressing concern that he remains in secret detention, and urging that he be granted immediate access to his family and lawyers, and to any medical attention he requires;
- urging that he be immediately released unless he is charged with recognizably criminal charges, in which case he should be brought immediately before the judicial authorities, in compliance with Algerian law and international human rights treaties ratified by Algeria.
