TUNISIA: Rachid CHAMMAKHI

Amnesty International has received testimony that Rachid Chammakhi, said by the Tunisian authorities to have died from natural causes while in custody in Nabeul, was severely tortured just before his death.

Amnesty International has received reports that Rachid Chammakhi was seen on the evening after his arrest on 24 October in the street in Sliman. He was guarded by about 30 policemen who were apparently using him to point out houses of suspected members of the illegal Islamic party <u>al-Nahda</u>. He was reported to be "in a lamentable condition", his hands handcuffed behind his back and with booodstains on his body. Amnesty International has also received testimonies from eyewitnesses stating that they saw Rachid Chammakhi on the night of 27 October 1991 in Nabeul Police Station. He was only wearing his underclothes and his body bore clear marks of torture and bruises; he was handcuffed and kept standing in the corridor for over three hours, and then was taken to a room for interrogation. The sounds of the beatings and of his screams were heard for several hours. Afterwards Rachid Chammakhi collapsed in the bathroom and was taken to hospital.

Eyewitnesses who saw Rachid Chammakhi in hospital stated that his body was covered in wounds and bruises; he talked with difficulty and complained of physical pain. He died during the night. His family was told the next day that he had died of liver failure. On 29 October his body was brought to the house under a heavy police escort which also accompanied the body to the place of burial. The family were not allowed to examine his body but they noticed a scar at the top of his chest and bruises on his head.

The Tunisian Government, in its public statements, has consistently denied that Rachid Chammakhi was tortured but has not set up a public inquiry into his death. However, the investigating judge (juge d'instruction) at Grombalia, at the urging of the Chammakhi family, opened an investigation into the causes of Rachid Chammakhi's death and has called the police and medical experts for questioning but this investigation has apparently now been closed.

RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters in French or Arabic, if possible:

- expressing concern at the latest information regarding the death of Rachid Chammakhi and urging that an immediate public inquiry be set up into the circumstances of his death; - expressing concern that this is the ninth death of a detainee in circumstances which strongly support that torture was the casue of death and reinstate Amnesty International's appeal for a public inquiry to be established to look into these cases
