TUNISIABachir ABID Ali JALLOULI Abdel Moumens BELANES

Amnesty International has learned that Bachir Abid was released on bail on 19 March 1996 pending trial. The court also ordered the release on bail of Abdel Moumens Belanes and Ali Jallouli, but they remain detained in connection with prison sentences they had received *in absentia* in 1992 and 1995 respectively. The case has been transferred from the criminal court to the court of first instance, and the charge of setting up a criminal association appears to have been dropped.

Bachir Abid, Abdel Moumens Belanes and Ali Jallouli were arrested between 28 and 30 November 1995 and were reportedly tortured whilst held in illegally prolonged incommunicado detention in the Ministry of the Interior. No investigation is known to have been carried out to date into complaints lodged by their defence lawyers, who confirmed that they still bore torture marks several days later.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in French.Arabic/English or in your own language:

welcoming the release on bail of Bachir Abid, but expressing concerns that Abdel Moumens Belanes and Ali Jallouli may be held as prisoners of conscience, and if this is the case they should be immediately and unconditionally released;
urging the authorities to ensure that a full, independent and impartial investigation is carried out into the allegations that they were tortured and ill-treated during incommunicado detention.
