#### TUNISIA: Tawfik RAJHI

Tawfik Rajhi was sentenced on 31 August 1993 to two years imprisonment and two years administrative control on charges of membership of an unauthorized organization (the Islamic movement al-Nahda). No evidence was brought to court of his membership to al-Nahda, and there was no charge or evidence that he had ever used or advocated violence. Amnesty International considers him as a prisoner of conscience.

After his arrest on 26 July he was held in illegally prolonged incommunicado detention for 23 days, during which his family and Amnesty International tried to no avail to obtain information on his whereabouts.

He stated in court that during incommunicado detention he was ill-treated and forced to sign a police statement without knowing the content, but no investigations into the allegations were ordered by the court.

# FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in French, Arabic, English or your own language:

- expressing your concern that Tawfik Rajhi was imprisoned as a prisoner of conscience and ask for his immediate and unconditional release;
- urging the authorities to ensure that the allegations that he was ill-treated during illegally prolonged incommunicado detention are thoroughly and impartially investigated;
- urging the authorities to ensure that no one is held in illegally prolonged incommunicado detention, as it is during this time that detainees are most at risk of ill-treatment.
