TUNISIA: Hamma HAMMAMI, member of the unauthorized Parti communiste des ouvriers tunisiens (PCOT), Tunisian Workers' Communist Party

Hamma Hammami, a prisoner of conscience imprisoned since his arrest on 14 February 1994, has had both of his custodial sentences reduced by six months following appeal. Amnesty International is concerned that he remains imprisoned solely for peacefully exercising his right to freedom of expression, and that he should be released immediately and unconditionally.

At the appeal hearing in Gabès on 20 June, Hamma Hammami's original sentence of four years and one month's imprisonment on charges of maintaining an illegal organization, holding unauthorized meetings and distributing leaflets, was reduced to three years and seven months' imprisonment. International observers who attended the appeal hearing reported that Hamma Hammami was not allowed to speak. His lawyers were reportedly prevented by the court from freely presenting the case for the defence and withdrew from the hearing as a result. The appeal went ahead without further legal representation for the defendant.

Hamma Hammami had also been sentenced to five years and six months' imprisonment at a trial in Sousse on 6 April. On 27 June this sentence was reduced on appeal to five years' imprisonment.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in French, Arabic, English or in your own language:

- repeating your concern that Hamma Hammami has been imprisoned solely for peacefully exercising his internationally recognized right to freedom of expression and association;
- insisting that he be immediately and unconditionally released;
- expressing concern that both Hamma Hammami and his lawyers were prevented from freely presenting the case for the defence at his appeal hearing in Gabès on 20 June 1994, in contravention of international standards for fair trial.
