UA 332/92 Incommunicado Detention/Fear of Torture 23 October 1992

TUNISIA: Abderrazak HAMZAOUI, student

Amnesty International is concerned for the safety of a Tunisian student who is being held in incommunicado detention. Abderrazak Hamzaoui has not been seen since his arrest on 19 September 1992 and the organization fears he is at risk of torture.

Abderrazak Hamzaoui is a second year student in computer programming at the University of Tunis. He was arrested on 19 September 1992 in the Ben Arous district of Tunis near the hostel where he was staying. His brother, Mongi Hamzaoui, a milk salesman, who was arrested on 16 September 1992, has been charged with supporting the illegal Islamic party Hizb al-Nahda. The arrest of Abderrazak Hamzaoui is also thought to be related to government repression of suspected supporters of al-Nahda. According to reports, Abderrazak Hamzaoui was taken to the police station in Kasserine near his home but later transferred to the Ministry of the Interior where he is still apparently held. There are also reports that he has suffered ill-treatment in detention.

Members of the family went to the Kasserine Police Station and the Ministry of the Interior on many occasions; on one occasion an official informed them that Abderrazak Hamzaoui's file was at the Ministry but no information was given as to his whereabouts. Amnesty International is concerned that Abderrazak Hamzaoui has had no access to his family or legal counsel since his arrest on 19 September 1992 and may be at risk of torture. Amnesty International is also concerned for his health as Abderrazak Hamzaoui is said to have suffered osteomyelitis as a child, leaving him with weakened bones in his left leg.

Amnesty International raised the case of Abderrazak Hamzaoui with the Tunisian Ministry of the Interior on 9 October 1992, but no information on his whereabouts has yet been received.

BACKGROUND INFORMATION

Over 9,000 supporters of $\underline{\text{Hizb al-Nahda}}$ have been arrested and detained over the last two years. Many of these have been held in prolonged incommunicado detention. Arrest dates have been systematically falsified in order to make it appear that the 10-day maximum limit of garde à vue detention laid down by Tunisian law is being adhered to. Hundreds have been tortured, many reportedly while being held in incommunicado detention within the Ministry of the Interior on Habib Bourguiba Avenue.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail

letters either in Arabic, French, English or in your own language:

- expressing concern that Abderrazak Hamzaoui is being held in incommunicado detention for longer than the 10-day maximum limit;
- urging that his family be allowed immediate access to him and that he receives all necessary medical care;
- urging that Abderrazak Hamzaoui be immediately released unless he is charged with a recognizable offence;
