TUNISIA: Hamma HAMMAMI, member of the unauthorized Parti communiste des ouvriers tunisiens (PCOT), Tunisian Workers' Communist Party

Hamma Hammami's family and lawyer were allowed to see him on 15 December, after being denied access for nine days, in breach of Tunisian law which guarantees detainees' right to access to a lawyer at all times. It is also in contravention of international standards relating to a detainee's access to legal counsel.

Hamma Hammami's whereabouts had remained unknown from 7 December, when he went on hunger-strike, until 14 December when his family and lawyer learned that he had been transferred on 9 December from Kasserine to Mahdia Prison. In both prisons he was placed in isolation in a punishment cell.

Hamma Hammami, a prisoner of conscience, is still on hunger-strike. He suffers from heart and kidney conditions and requires special medical care. For the first two days of his detention at Mahdia Prison, he was denied water and access to a toilet. He eventually was seen by a prison doctor and was placed in a cell with improved facilities.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in French, Arabic, English or in your own language:

- deploring that  $\operatorname{Hamma}$   $\operatorname{Hammami}$  was denied water and access to a toilet for two days;
- expressing serious concern that Hamma Hammami was unable to see his lawyer or family for nine days;
- urging the authorities to ensure that Hamma Hammami continues to have access to proper medical care;
- reiterating that Hamma Hammami is a prisoner of conscience and should be immediately and unconditionally released.
