TUNISIARachida BEN SALEM (f)

Amnesty International has learnt that prisoner of conscience Rachida Ben Salem was transferred on 31 May 1997 from the Ministry of the Interior in Tunis, where she had been held in incommunicado detention, to Mannouba women's prison, also in the capital.

She was brought before the $juge\ d'instruction$ (investigating judge) on 2 June 1997, and was reportedly charged, together with at least five other individuals, with belonging to a criminal gang. This charge is increasingly being used against known or suspected supporters of unauthorized political opposition groups. It carries a heavier sentence than the charge of belonging to or supporting an unauthorized association, which was previously more commonly used against political opponents.

Rachida Ben Salem was reportedly not subjected to ill-treatment during her incommunicado detention in the Ministry of the Interior. However, she was allegedly insulted and had her hair pulled during periods of interrogation in two police stations following her arrest.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, Arabic, English or in your own language:

- calling for the immediate and unconditional release of Rachida Ben Salem as a prisoner of conscience;
- expressing concern that she was reportedly subjected to ill-treatment in two police stations prior to her detention in the Ministry of the Interior, and urging that she not be subjected to further ill-treatment.
