TUNISIAMohamed MOUADDA, former leader of opposition political party and other conditionally released prisoners of conscience

Mohamed Mouadda, former leader of the opposition *Mouvement des Démocrates Socialistes (MDS*, Movement of Social Democrats), and under house arrest since 14 April 1997, was reportedly ill-treated by members of the security forces during an attempt to leave his house on 4 July. He apparently told those in charge of his surveillance that he would rather be sent back to prison than remain under house arrest. He was allegedly beaten and forced to return inside.

Since Mohamed Mouadda has been under house arrest he has been prevented from both leaving his home and from receiving visitors except for his immediate family. Even his wife's doctor is unable to attend to his wife in spite of her poor health. Additionally his phone line has been disconnected and his mail intercepted.

On 28 June Mohamed Mouadda's son, Talel, was arrested outside his home and interrogated for several hours about his father's contacts with the outside world in the Ministry of the Interior. His arrest came immediately after a statement issued by Mohamed Mouadda. In it he condemned the campaign of intimidation and slander by the Tunisian authorities against human rights defenders recently invited to a meeting at the European Parliament on the human rights situation in Tunisia. This meeting was also attended by Amnesty International and other international human rights organizations.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, Arabic, English or in your own language:

- calling on the Tunisian authorities to lift the house arrest order of Mohamed Mouadda immediately and unconditionally;
- urging that Mohamed Mouadda's allegations of ill-treatment be promptly, impartially and independently investigated;
- protesting at the practice by the Tunisian authorities of subjecting released prisoners of conscience to continuous harassment;
- calling for all human rights and political activists to be able to carry out their non-violent activities and associations free from fear of arrest and intimidation, in accordance with international human rights standards.
