<u>GUATEMALA: AMNESTY INTERNATIONAL DELEGATION VISITS GUATEMALA TO URGE FOR RESTORATION OF CONSTITUTIONAL GUARANTEES FOR</u> <u>Human rights protection</u>

Amnesty International today sent a four person delegation to Guatemala [to arrive on Thursday, 3 June]. Amnesty International's delegation will assess at first hand the effects on human rights protection of the present institutional situation in the country following the measures taken by President Jorge Serrano Elías and his subsequent forced resignation.

Defence Minister General José Domingo García Samayoa announced the President's resignation on 1 June 1993 and said that the Constitutional Court would hold power until Congress chooses a new leader. According to the government's press department, President Serrano was forced out of office by an alliance of the army, opposition parties, business leaders and other sectors. The Amnesty International delegates will raise the organization's concerns regarding these changes directly with Guatemalan authorities and will urge for the restoration of constitutional guarantees for human rights protection.

These events follow a series of measures announced by President Serrano on 25 May. Annesty International has been gravely concerned at the threats to human rights posed by announcements by the President that he had partially suspended the Constitution, dissolved Congress, dismissed Supreme Court and Constitutional Court judges, and replaced the rule of law in the country with rule by decree. Amnesty International has been further concerned to learn that various governmental human rights entities such as the Human Rights Procurator's Office and the Procurator's Office of the Public Ministry were suspended and attempts apparently made to arrest certain government officials associated with official human rights initiatives in the country. Amnesty International also wishes to establish the whereabouts and current legal situation of a number of trade unionists, also reportedly detained.

Annesty International has also been deeply disturbed to learn of a number of measures which had been taken by President Serrano to curtail freedom of expression and prevent both Guatemalans and concerned international observers from learning of the true human rights situation in the country. It was reported for example that the offices of both governmental and independent human rights reporting entities have been surrounded by the security forces, and their staff prevented from communicating both within Guatemala and abroad. In addition, warrants had reportedly been issued for the arrest of a number of journalists and Article 35 of the Constitution concerning freedom of expression suspended. According to further information received by Annesty International, certain television channels, radio stations and newspapers had been prevented from publishing or broadcasting; those which have continued to publish or broadcast have reportedly only been able to do so under censorship.

The type of concerns which Amnesty International intends to discuss with the authorities were sent in a communication to President Serrano on 26 May 1993. In that communication, Amnesty International also set out the steps which it believes to be imperative to ensure respect for human rights in the country. These include restoration of constitutional guarantees for human rights protection, and assurances for the personal safety of all detainees, who must be protected from extrajudicial executions, "disappearance," and torture or other cruel, inhuman or degrading treatment. While in Guatemala, Amnesty International's delegation will also emphasise the organization's view that a public statement should immediately be issued to express the authorities' commitments to fully protect the human rights of all citizens, including human rights defenders. Such a statement should make clear that all infractions of human rights standards will not be tolerated and will be severely punished. Amnesty International will also repeat its request that: information to be made public concerning all those detained; any individuals in custody to be permitted access to their families and to lawyers; and anyone arrested for their conscientiously-held beliefs and who are known not to have used or advocated violence, be immediately and unconditionally released. Amnesty International's delegation will call again on the authorities to immediately re-establish the functions of the judiciary, public ministry and legislature designed to protect human rights.

Amnesty International has also called upon the state members of the Organization of American States to take energetic measures in favour of the restoration of the protection of human rights and the rule of law in Guatemala.
