## **GUATEMALA: AMNESTY INTERNATIONAL MEETS NEW PRESIDENT**

On 9 June Amnesty International delegates in Guatemala delivered a letter addressed to the new president, Ramiro de León Carpio, formerly the Human Rights Procurator. On 6 June he had been voted in as president almost unanimously by Congress, following the withdrawal of the only other candidate. Amnesty International delegates met President León de Carpio on the day of his appointment, conveying the organization's concerns and expressing their desire to have further personal contact with him in the very near future. The president was amenable to this and said that he would make himself available.

The text of the letter is as follows:

Your appointment as President of the Republic raises real hope that the respect and protection of human rights will be an integral part of your government's programme.

As you know, Amnesty International has strived alongside other non-governmental organizations for many years to stop the very grave human rights violations committed by the security forces and the abuses committed by armed opposition groups.

The present situation of the country requires, in our opinion, the urgent implementation of certain measures that would demonstrate the firm will of your government to improve the protection of human rights of the Guatemalan people. Such measures are the following:

- The government should publicly declare that the protection of human rights of all sectors of Guatemalan society will be the fundamental policy of the state, in accordance with the constitution.
- To the extent that the protection and promotion of human rights is a task of all the Guatemalans, the non-governmental human rights organizations, as well as other sectors of civilian society committed to their defence, should be consulted about the institutional reforms necessary for a lasting improvement in the protection of human rights.
- The government should declare in an unequivocal way that there will be no impunity for crimes against human rights in the future, and that the new government will take the necessary measures to try to resolve the significant legacy of violations committed by past regimes. The right to truth and justice of the victims, their relatives and society as a whole, should be reaffirmed without ambiguity.
- The government should ensure effective court jurisdiction over all cases of human rights violations, whether these are committed by civilians or by the military while on duty or not.
- The government should take measures both for the protection of fundamental rights of vulnerable people, such as street children and the indigenous peoples, people living in the shanty towns, the displaced and the repatriated.
- The government should ensure that, in the context of the peace process, the protection and defence of human rights constitutes a cornerstone in whatever agreement is reached with the armed opposition.

Amnesty International is aware of the formidable difficulties that confront your government at present. However, I can guarantee Your Excellency that all those committed to the defence of human rights in the international community will appreciate and support your action and the efforts of the Guatemalan people in this regard, as has been shown during the suspension of constitutionality on 25 May until its reestablishment which allowed for your accession to the presidency.
