INDIA: GOVERNMENT FAILS TO ACCEPT AMNESTY INTERNATIONAL'S PROPOSED VISIT TO BOMBAY

Amnesty International greatly regrets that the Indian government has not been able to agree to an Amnesty International visit to Bombay which the organization had proposed take place from 18 - 24 July 1993.

Amnesty International had made the proposal after Home Minister SB Chavan's specific assurances to the press on 22 April that Amnesty International "can go to Bombay and speak to whoever they wish, so long as they also meet the Chief Minister of Maharashtra". India had earlier turned down Amnesty International's request to visit Bombay in April.

Amnesty International had made its latest request in a 16 June letter to Mr Sharad Pawar, the Chief Minister of Maharashtra. The organization proposed that its delegation should visit Bombay to discuss matters relating to police behaviour and training in view of allegations that some policemen had failed to act impartially during the disturbances in the city in December 1992 and January this year. The delegation would have comprised of Mr Rod Morgan, the Dean of the Faculty of Law of Bristol University, and a Dutch lawyer from Amnesty International's International Secretariat.

Amnesty International had also asked to discuss more recent allegations of ill-treatment of Muslims in detention as well as the action the government has taken in respect of two dozen people reported to have died in police custody in the state between 1985 and 1993. Amnesty international had requested to meet the Chief Minister, the Bombay Police Commissioner, as well members of civil liberties organisations and others with first hand information.

The Indian High Commission in London stressed that the Indian Government was not opposed to such a visit, but that the dates which Amnesty International had requested could not be accommodated. Amnesty International will now propose that its visit to Bombay take place in the autumn.
