## ISRAEL AND THE OCCUPIED TERRITORIES: AMNESTY INTERNATIONAL CALLS FOR STRONG HUMAN RIGHTS SAFEGUARDS TO BE INCLUDED INTO PEACE SETTLEMENT

Amnesty International has called on the Israeli and Palestinian authorities to ensure that strong human rights safeguards are an integral part of any peace settlement between them.

In letters to Yitzhak Rabin, Prime Minister of Israel, and Yasser Arafat, leader of the Palestine Liberation Organization (PLO),
Amnesty International urged that, as a minimum, both sides make an explicit and formal commitment to fully implement international human rights standards

in the context of any agreement concerning the Occupied Territories. Such standards include the International Covenant on Civil and Political Rights; the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment; and the Code of Conduct for Law Enforcement Officials. The organization also called for all law enforcement officials to receive adequate training in such standards.

No reference to human rights is contained in the Declaration of Principles on Interim Self-Government Arrangements signed by the Israeli Government and the PLO on 13 September 1993. This document envisages a situation in which, over a period of up to five years, Israeli forces as well as a Palestinian police force will be responsible for law enforcement in the Occupied Territories. Detailed arrangements are to be negotiated in a number of specific agreements.

In its appeals, Amnesty International has also urged the Israeli Government to address as a matter of urgency human rights issues including the detention or imprisonment of prisoners of conscience, specifically those accused solely of membership of Palestinian organizations; the continuing use of administrative detention; torture and ill-treatment; killings of Palestinian civilians; deportations; and the destruction of houses.

Amnesty International has also repeated its concerns about the arbitrary killings of Palestinians suspected of "collaborating" with the Israeli authorities and sought a commitment from the PLO not to introduce death penalty provisions in the Occupied Territories.

Amnesty International believes that full respect of human rights is an essential precondition for any lasting peace settlement.
