

OVERVIEW

Every criminal trial tests the state's commitment to justice and respect for human rights. Whatever the crime, if people are subjected to unfair trials, justice is not served for the accused, the victim of the crime or the public.

The justice system itself loses credibility when trials are unfair and people are unjustly convicted and punished. Unless human rights are upheld in the police station, the detention centre, the court and the prison cell, the state has failed in its duties and betrayed its responsibilities.

The Amnesty International Fair Trial Manual is a practical and authoritative guide to international and regional

standards for fair trial. These standards set out minimum guarantees designed to protect the right to a fair trial in criminal proceedings.

The *Manual* explains how fair trial rights have been interpreted by human rights bodies and by international courts. It covers rights before and during trial, and during appeals. It also covers special cases, including death penalty trials, cases brought against children, and fair trial rights during armed conflict. This is the second, updated and revised edition of the *Manual*.

BACKGROUND AND RATIONALE

Since 1998, the *Amnesty International Fair Trial Manual* has been the trusted guide to fair trial standards for legal professionals the world over. The *Amnesty International Fair Trial Manual: Second Edition* is the fully revised and updated text.

Drawing on Amnesty International's standing as an authoritative voice in interpreting international human rights law, the *Manual* provides a comprehensive, practical and accessible guide to international and regional fair trial standards.

Since its first publication in 1998, the *Manual* has enjoyed notable success in terms of global reach and impact. The first edition was translated into 14 languages and is used by a wide range of practitioners, including NGO staff, government officials, legislators, UN bodies, the OSCE, judges, lawyers and trial observers. The UN and others have found it to be a valuable and user-friendly resource for delivering training and facilitating international workshops worldwide. It is used in on-the-ground missions and in post-conflict situations, including by the UN. Bodies including the EU Commission have turned to the *Manual* for guidance in drafting international legal standards.

For many years, Amnesty International has received requests for an updated *Manual* from intergovernmental and non-governmental organizations, lawyers and other human rights defenders around the world. The second edition answers this call.

A number of changes in the global legal and political context have taken place since the first edition was published. New standards have been adopted, for example relating to women deprived of their liberty and the right to access legal aid. (The first edition cites 65 legal standards; the second edition cites more than 140.) There is growing recognition that many fair trial rights apply at all times and in all circumstances, even during states of emergency and armed conflicts. In the aftermath of the 9/11 attacks in the USA, human rights, including fair trial rights, faced particular challenges. There is now more clarity that a state's human rights obligations apply beyond its borders when it exercises control over a people or territory. Along with increased attention to discrimination within the criminal justice system, there is a growing consensus that fairness requires respect for the rights of victims in a manner consistent with the rights of the accused.

RELATED TITLES

Since then, other manuals have been produced, but these are either lengthy and expensive treatises, or do not include case examples or regional standards. The *Amnesty International Fair Trial Manual* is the most comprehensive and accessible to a general audience.
