## Amnesty International Reports & Statements:

- **9 July: Iran:** Ai has urged the Iranian authorities not to execute by any method a 43-year-old woman convicted of adultery, following an official statement that she will not be executed by stoning. The Iranian Embassy in London announced that Sakineh Mohammadi Ashtiani would not be stoned to death. - **9 July: China:** Chinese security forces cancelled a documentary screening by an HIV/AIDS education group, which AI is strongly criticising as part of the ongoing harassment of peaceful public health educators. China's internal security police questioned staff of the Beijing HIV/AIDS education NGO Aizhixing Institute of Health Education on 7 July and instructed them to cancel the show planned for 8 July. The film screening did not go ahead and the Aizhixing event-organiser has resigned from coordinating the event. Aizhixing staff have been so frequently subjected to questioning and harassment that the director Wan Yanhai left China in May 2010 to avoid constant police interrogations and detentions. - **8 July:** Germany's failure to thoroughly investigate claims of police ill-treatment and the use of excessive force has denied justice for victims of abuse, Al said in a recent report. - **7 July: Kenya:** Women and girls in Nairobi's slums live under the constant threat of sexual violence, leaving them often too scared to leave their houses to use communal toilet and bathroom facilities, Al said in a recent report. *Insecurity and Indignity: Women's experiences in the slums of Nairobi, Kenya* details how the failure of the government to incorporate the slums in urban plans and budgets has resulted in poor access to services like sanitation, which hits women in slums and

**7 July: UK:** Al has called on the UK government to ensure that its inquiry into UK complicity in torture and other human rights violations of those detained abroad since 11 September 2001 is thorough, independent and as transparent as possible. **7 July: Tunisia:** Al is calling on the Tunisian authorities not to imprison ailing journalist Fahem Boukadous, after a court upheld his four-year prison sentence over his reporting of 2008 protests against unemployment and high living costs. Fahem Boukadous is currently in hospital suffering from severe asthma. If Fahem Boukadous is imprisoned, Amnesty International would consider him to be a prisoner of conscience, detained solely for his peaceful exercise of his right to freedom of expression. "In the coming few hours, the police might come and take me out of the hospital. I am an opinion holder and a defender of rights. I am not scared of the arrest and the prison. - **5 July: Syria:** All has called on the President of Syria to reveal exactly what happened to 52 prisoners who went missing during and after disturbances at a military prison that also left at least 22 people dead. The clashes between inmates and military police at Saydnaya Military Prison near Damascus began on 5 July 2008. - **29 June: Zimbabwe:** Three human rights monitors were captured and beaten with logs by Zanu-PF supporters on Sunday, in the latest incident since a process of consultation over a new Zimbabwean constitution began on 16 June.
