POC SENTENCED TO ONE YEAR IN PRISON

On 22 December, Dr. Mudawi Ibrahim Adam, a human rights defender and former director of the Sudan Social Development Organization (SUDO), was sentenced to a year in prison without a full trial. He is a prisoner of conscience, held solely in relation to his human rights work.

Dr. Mudawi Ibrahim Adam was called to appear in court in Khartoum, the capital of Sudan, on the morning of 22 December in relation to embezzlement charges that had previously been brought against him by the Humanitarian Aid Commission (HAC), a governmental body in charge of coordinating humanitarian efforts in Sudan. The charges followed a series of audits in 2008 and 2009 that did not show any unlawful activity by Dr. Mudawi Ibrahim Adam.

Dr. Mudawi Ibrahim Adam's last court appearance in relation to his case was in March 2009, immediately after SUDO, amongst other national and international organizations, was closed by the HAC. During his last court appearance, Dr. Mudawi Ibrahim Adam was acquitted by the judge for lack of evidence. The HAC appealed against the court's decision and Dr. Mudawi Ibrahim Adam was informed that the first instance judge would be reviewing his case on 22 December.

On the morning of 22 December, although reportedly no further evidence was submitted to court and despite the absence of a full trial, the same judge convicted Dr. Mudawi Ibrahim Adam of financial mismanagement and sentenced him to one year of imprisonment and a fine of 3000 Sudanese pounds (USD 1250). Dr. Mudawi Ibrahim Adam was immediately taken to Kober prison and transferred on 23 December to Soba prison.

Dr. Mudawi Ibrahim Adam was arrested on three previous occasions between 2003 and 2005 in relation to his human rights work, and kept for periods in solitary confinement without access to a lawyer and his family. Following his initial arrest on 28 December 2003, he went on hunger strike demanding to be released or charged. He is the winner of a 2005 Human Rights First award and Front Line award in relation to his human rights work in Sudan.

PLEASE WRITE IMMEDIATELY in English, Arabic or your own language:

- Calling on the authorities to immediately and unconditionally release Dr. Mudawi Ibrahim Adam on the grounds that he is a prisoner of conscience held solely in relation to his lawful work in the defence of human rights;
- Calling on the authorities to allow Dr. Mudawi Ibrahim Adam unrestricted access to his family and to legal counsel:
- Calling on the authorities to immediately end the harassment and detention of human rights activists who are peacefully exercising their work and their rights to freedom of expression, association and assembly.

ADDITIONAL INFORMATION

SUDO is an organization that was promoting human rights and social development and was one of the NGOs closed down by HAC following the arrest warrant against President Al Bashir, when the government closed down three national humanitarian and human rights organizations and expelled 13 international humanitarian organizations. SUDO filed an appeal against its closure by the HAC commissioner. On 21 April 2010, SUDO won the appeal on the grounds that the HAC commissioner had no authority to dissolve SUDO. The organization has not however resumed its activities.

Human rights defenders, civil society activists, journalists and members of the opposition continue to be targeted by the security forces in Sudan in relation to their work. A large number of human rights defenders were forced to flee the country following the arrest warrant against President Al Bashir, while those who remain have been silenced and prosecuted in relation to their work.

Four journalists were prosecuted in 2010 in relation to their work which was seen as critical of the government, and 13 individuals, including activists, journalists and a lawyer remain in detention since 30 October in relation to their work.

The Humanitarian Aid Commission limits the work of human rights and humanitarian organizations operating in Sudan, particularly in Darfur, and were responsible for closing down a number of organizations and expelling their staff members.
