URGENT ACTION

ENVIRONMENTAL ACTIVISTS THREATENED

Staff at the Centre for Environmental, Social and Legal Action (Centro de Acción Legal, Ambiental y Social de Guatemala – CALAS) have received death threats. In recent months, CALAS have been promoting a public campaign against corruption and the building of a gas plant in a nature reserve. Their staff are all in danger.

The director and legal adviser at CALAS, Yuri Melini and Rafael Maldonado, received envelopes on 29 August, at 9.30am. Each contained the same documents: a threat; papers from the Office of the Comptroller General (*Contraloria General de Cuentas*); and mug-shot photographs of 18 men, that appear to have been taken from police files.

The note read, *Metan preso a quien quieran y sigan haciendo el show que quieran...* Nosotros empezaremos a ajustar nuestras cuentas después del 14-01-2012.[14 de enero de 2012 es el primer día del mandato del nuevo presidente en Guatemala] Sera problema de los que vienen y ustedes dejaran de estar haciendo escandalo ("Get whoever you want arrested and keep doing the show you want... We will set our records straight after 14-01-2012. [14 January 2012 is the first day of the new President's term in Guatemala.] It's going to be a problem for those who come next and you're going to stop making a fuss"). It also warned, *Rafel Maldonado sientete triunfador... Yuri, Yuri no aprendes que la vida hay que llevarla en paz* (Rafel Maldonado you (must) feel like a winner [...] Yuri, Yuri don't you learn that life must be lived peacefully").

In recent months, CALAS has promoted a public campaign against corruption and the building of a gas plant in a nature reserve in north-eastern Guatemala, Punta de Manabique, Izabal department. CALAS filed a complaint with the Constitutional Court on the case and had also lobbied for the dismissal of a civil servant responsible for management of nature reserves, on the grounds of corruption.

PLEASE WRITE IMMEDIATELY in Spanish, English or your own language:

- Calling on the authorities to order an independent, thorough and impartial investigation into the threats made against CALAS staff, publish the results and bring those responsible to justice;
- Urging them to take immediate steps to provide full and appropriate protection to Rafael Maldonado and other CALAS staff members, in accordance with their wishes;
- Reminding them that human rights defenders have a right to carry out their activities without any unfair restrictions or fear of reprisals, as set out in the UN Declaration on Human Rights Defenders.

ADDITIONAL INFORMATION

Guatemalan environmental activists have been attacked to stop them from carrying out their legitimate activities. They work to protect the environment and the human rights of indigenous and peasant communities whose livelihoods depend upon the environment.

On 8 September 2008, CALAS director Yuri Melini was shot by masked men, apparently in connection with his work (See UA 248/08, AMR 34/021/2008, 8 September 2008). Following the attack, Yuri Melini and CALAS were granted protection from the state.

On 10 January 2007, Carlos Albacete Rosales and Piedad Espinosa Albacete of the environmental organization Trópico Verde were shot at while they were in a taxi. They managed to escape unscathed. In January and February 2007, Flaviano Bianchini of the environmental organization MadreSelva Collective (*Colectivo MadreSelva*) was threatened with death and followed on several occasions (see *Persecution and Resistance: The experience of human rights defenders in Guatemala and Honduras*, AMR 02/001/2007).
