URGENT ACTION

MIGRANTS' RIGHTS WORKERS THREATENED

Members of staff working at the Usumacinta Human Rights Centre (Centro de Derechos Humanos del Usumacinta, A.C) in the town of Tenosique, Tabasco state, southern Mexico, have been repeatedly threatened and intimidated. Amnesty International believes that these threats are in reprisal for their human rights work, particularly on migrants' rights.

Three members of staff working at the Usumacinta Human Rights Centre have been repeatedly subjected to acts of intimidation and attack. On 29 June, the Director of the Human Rights Centre, **Ezequiel Serafín Esteban**, was leaving work on his motorbike when a van with tinted windows closed in on him and forced him off the road. He fell off his motorbike and was injured as a result. The driver of the van has not been identified.

Minelia Aguilar May, a member of staff responsible for migrants' rights at the Human Rights Centre, has reported that she has repeatedly noticed vans with tinted windows parked in front of the entrance of her house. On 14 July, Minelia Aguilar May was followed by one of the vans as she left her house the van narrowly missed her as it drove past her.

According to **Fredi Flores Mecia**, who also works on migrants' rights at the Human Rights Centre, he has been repeatedly detained by the local Municipal Police based on unfounded allegations. Since May 2011 he has been detained three times. During these arrests the Municipal Police officers have reportedly insulted the Usumacinta Human Rights Centre. On 19 June, in the latest of a series of baseless detentions, Fredi Flores Mecia was handcuffed to the back of the police van and left out in the rain. Some of the police officers present threatened him saying that the detentions wouldn't stop until he withdrew a complaint he had filed months earlier against the Municipal Police for the ill-treatment he suffered during a previous arrest on 9 October 2010.

Complaints have been filed with Mexico's National Human Rights Commission against all these acts of intimidation.

- Expressing concern for the safety of Ezequiel Serafín Esteban, Minelia Aguilar May and Fredi Flores Mecia and other staff at the Usumacinta Human Right Centre;
- Calling for authorities to provide immediate protection measures to be implemented in accordance with the wishes of staff at the Usumacinta Human Right Centre to guarantee their safety:
- Calling on the authorities to investigate all attacks, threats and intimidation against staff who run the Usumacinta Human Right Centre and for those responsible to be brought to justice.
