UK. Doctors play a key role in investigating child abuse. Doctors involved in child protection work are receiving death threats and hate mail, *The BBC* has learned. Belarus. Text of report by Belarusian TV on 11 March. The Belarusian Constitutional Court has recommended that the government introduce a moratorium on the death penalty and abolish capital punishment. (no link)

USA. Shortly before the scheduled execution of Hung Thanh Le, a Vietnamese foreign national on Oklahoma's death row, Governor Brad Henry granted a stay of execution. USA Juvenile death penalty. Human Rights Watch reports that two states have raised the age of execution to 18 in conformity with international standards. International treaties and customary international law forbid capital punishment for offenders under the age of 18 at the time of the offense for which they were convicted. HIV/AIDS

China. Xinhua, Wuhan, Hubei will organize 30 medical workers and form 10 AIDS expert control brigades who will go to stay in 21 hard-hit epidemic areas to begin treatment work. According to explanations, HIV infections have been increasing continuously since 1988, when Hubei found its first case of HIV-infection. By December 2003, there were 1301 registered cases of HIV/AIDS in the province. At present, Hubei has entered a period of rapid increase of infection and high number of full-

blown AIDS cases, and the state of AIDS prevention and control is severe. *China Aids Info* (9 March)

South Africa's government is not giving rape victims drugs to combat HIV/Aids, as it promised, lobby group Human Rights Watch says. South Africa has the highest number of HIV positive people in the world - some 5 million - and also a high incidence of rape. Women are more likely to be raped than to learn how to read, statistics show. Medical discussion and protest

Canada. A new law that would make it mandatory for doctors in Ontario to report gunshot wounds to police is stirring up debate within Canada's emergency medicine community. If approved by the legislature this spring, the controversial law will become the first of its kind in the country. Currently hospital staff are not legally required to inform police when they treat a patient who has been injured by a firearm. But physicians are obligated to respect the confidentiality requests of their patients despite any demands for information from police. *CMAJ*(2 March)

Mozambique. A Brazilian nun responsible for exposing a human organ trafficking ring in Mozambique has been murdered. The traffickers are said to harvest sex organs from children to be sold as charms for the practice of witchcraft in ceremonies said to increase wealth or sexual vigour.
