USA. James Barney Hubbard became the oldest person to be executed in the USA under present death penalty laws when he was put to death in Alabama on 5 August. Hubbard was sentenced to death for the murder of Lillian Montgomery in 1977. He had been on death row for more than a quarter of a century, and was reported to suffer from dementia which sometimes led him to forget who he was and why he was on death row. Human Rights

Botswana. Mr Oliphant Mfa, assistant minister for presidential affairs, announced that Botswana will not stop the practice of flogging the thousands of Zimbabweans who cross illegally into Botswana every month, fleeing their country's economic crisis. Mr Mfa was responding to criticism from a Zimbabwean minister who described the practice of flogging as "punitive". Certain crimes are punishable by corporal punishment in Botswana instead of jail terms.

Indonesia. Following the acquittal of four high-ranking Indonesian officials who had previously been found guilty by the Human Rights Court in Jakarta of crimes against humanity in East Timor, Human Rights Watch called on the United Nations to take steps to create a judicial process to bring to justice those responsible for these crimes. The acquittal of the four means that all Indonesians indicted for crimes against humanity in East Timor have now been either acquitted or overturned and only two of the 18 who were originally tried by the court may serve prison time.
