EQUATORIAL GUINEA: Norberto "Tito" Mba Nze, aged 38, car mechanic

On 10 April 1995 Norbeto "Tito" Mba Nze, Mariano Nsogo, Baltasar Nsogo Ntutumu and Pascual Nsomo Mba were arrested in Akonibe, in the south east of the mainland region of Río Muni, and subjected to beatings on the sole of the feet and other parts of the body.

Members of the Convergencia para la Democracia Social (CPDS), Convergence for Social Democracy, were able to see Norberto "Tito" Mba Nse on the morning of 13 April, at the police station in Akonibe where the four men are detained, but they were unable to see the other detainees. Norberto Mba Nze told his visitors, in the presence of police authorities, that he had been arrested for his political activities and for trying to perform his duty as an electoral census observer. He also told them that he, and the other three, had been severely beaten on the soles of the feet and other parts of the body. According to his visitors, Norberto Mba Nze had difficulty in walking; his left arm was injured and he had it elevated in a sort of sling. None of the detainees have reportedly received medical treatment.

Norberto "Tito" Mba Nze has been briefly detained on previous occasions for his peaceful political activities. His most recent arrest was in late February 1994.

Elías Nsó Ondo and Avelino Mocache, both members of the *Partido del Progreso* (PP), Progress Party, and electoral census observers were arrested in Evinayong, Centro-Sur province of Río Muni on 9 April 1995, also for attempting to supervise the compilation of the census. They are believed to be held in the police station in Bata, the capital of Río Muni.

Norberto "Tito" Mba Nze is the local representative of the CPDS. Mariano Nsogo and Baltasar Nsogo Ntutumu are also members of the CPDS while Pascual Nsomo Mba is a member of the PP. The four are district observers in the compilation of the electoral census.

BACKGROUND INFORMATION

Since the beginning of 1995 scores of peaceful political activists and members of opposition parties delegated to monitor the compilation of the electoral census have been arbitrarily arrested. Many have been tortured or ill-treated and about a dozen have been briefly detained.

Tension escalated after the government announced that municipal elections would take place during the first half of 1995 and started compiling the electoral census, which was to be supervised by opposition parties. In February at least

15 military officers and civilians were arrested and accused of plotting to overthrow the government. They are expected to be tried by a military court shortly.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- -expressing concern about the unlawful imprisonment of Norbeto "Tito" Mba Nze, Mariano Nsogo, Baltasar Nsogo Ntutumu and Pascual Nsomo Mba and at reports that they were severely beaten;
- expressing concern that Norbeto "Tito" Mba Nze, Mariano Nsogo, Baltasar Nsogo Ntutumu and Pascual Nsomo Mba and Elías Nsó Ondo and Avelino Mocache appear to have been arrested solely on account of their peaceful political activities; stating that unless they are charged with a recognizably criminal offence they be released immediately and unconditionally;
- urging that they be allowed access to family, lawyers and medical treatment immediately;
- -asking for reports of torture to be thoroughly investigated, the results made public, and that those responsible be brought to justice.
