SUBMISSION TO THE 45th SESSION OF THE UPR WORKING GROUP, JANUARY-FEBRUARY 2024

SUMMARY

This submission was prepared for the fourth Universal Periodic Review (UPR) of Nigeria in January – February 2024. In it, Amnesty International evaluates the implementation of recommendations made to Nigeria in its previous UPR in 2018, including in relation to enforced disappearances, human rights violations by the security forces, torture and other ill-treatment, gender-based violence and gender equality, and the impact of the oil industry on human rights.

It also assesses the national human rights framework with regard to the Nigerian Constitution and the Terrorism (Prevention and Prohibition) Act, 2022, as well as the Violence Against Persons (Prohibition) (VAPP) Act, 2015.

With regard to the human rights situation on the ground, Amnesty International raises concerns about freedom of expression and peaceful assembly, unlawful killings, armed conflict, violence against women, forced evictions, oil pollution in the Niger Delta, LGBTI people's rights, and the death penalty. It ends with a set of recommendations to Nigeria which, if implemented, would contribute to improving the human rights situation.

FOLLOW UP TO THE PREVIOUS REVIEW

- 1. Nigeria supported 240 of 290 recommendations made during its previous UPR in 2018. The government noted 50 recommendations, including all recommendations to ratify international treaties, all recommendations on decriminalizing same-sex sexual relations and 19 of the 20 recommendations aimed at ending recourse to the death penalty.¹
- 2. In line with a supported recommendation, on 14 August 2021, the Nigerian Correctional Service Bill was signed into law to address fundamental lapses in the Prisons Act, 1972.²
- 3. Despite supporting three recommendations to end enforced disappearances, including to develop a database of missing persons in Nigeria, and to allow independent human rights investigators full access to investigate allegations of enforced disappearances,³ enforced disappearances are still prevalent in the country. Several people have been subjected to enforced disappearance between 2019 and 2022.⁴ The government has not yet established an official database of missing persons, and there is still no justice for victims of enforced disappearance and their families.
- 4. Nigeria supported over 20 recommendations to ensure respect for human rights in counterterrorism operations, including to protect the lives of civilians and to avoid extrajudicial killings and to investigate violations by security forces.⁵ Regrettably, since 2019, security forces have consistently violated human rights in the context of military operations conducted against Boko Haram in the north-east, and the violence in southeast Nigeria.⁶ The reports of the army-led Special Board of Inquiry and the Presidential Investigative Panel set up in 2017 to review compliance by the armed forces with human rights are yet to be made public, despite Nigeria's commitment in the previous review to do so.⁷
- 5. Nigeria is yet to implement the supported recommendation to amend the Police Force Order 237, which provides for much wider scope for the use of lethal force than is permissible under international law and standards.⁸
- 6. Nigeria supported eight recommendations aimed at preventing torture and other ill-treatment including to establish a national torture preventive mechanism for independent monitoring in all detention facilities and to create a central database of all places of detention.⁹ However, none of the accepted recommendations have been implemented. Despite criminalization of torture under the Anti-Torture Act (2017), torture and other ill-treatment has remained pervasive in Nigeria.¹⁰
- 7. In 2020, Amnesty International documented over 82 cases of torture by the Special Ant-Robbery Squad (SARS) unit of the Nigeria police, which was notorious for unlawful arrests, torture and other ill-treatment, and unlawful killings.¹¹ In October 2020, the Nigerian authorities disbanded SARS. However, all the officers in the SARS squad were redeployed and none of them has been prosecuted.
- 8. Nigeria supported over nine recommendations in relation to gender-based violence and gender equality, including to enact the Gender and Equal Opportunities (GEO) Bill, and to implement the Violence Against Persons (Prohibition) (VAPP) Act, 2015 in all the states.¹² The GEO bill is yet to be passed into law. Thirty-four states have domesticated the Act. Kano and Katsina states are yet to do so. In March 2022, the National Assembly voted against five bills which sought to promote gender equality in Nigeria.¹³ After protests by women's groups, the National Assembly rescinded its decision on three of the bills.¹⁴

THE NATIONAL HUMAN RIGHTS FRAMEWORK

9. Chapter 4 of the 1999 Constitution of Nigeria¹⁵ provides that fundamental rights include only civil and political rights, which are enforceable in the courts. Economic, social and cultural rights, as provided for in Chapter 2 as Fundamental Objectives and Directive Principles of State Policy, are not enforceable in the courts.



- 10. Nigeria is a party to several international human rights treaties, but only some have been domesticated into domestic law.¹⁶
- 11. The Terrorism (Prevention and Prohibition) Act, 2022 repealed the Terrorism (Prevention) Act, 2011 (as amended).¹⁷ However, the Act contains provisions which violate Nigeria's Constitution and international human rights obligations. Section 35 of the Constitution requires suspects to be brought before a court within 48 hours, whereas the Act provides for extended detention of individuals suspected of involvement in terrorism.¹⁸ The Act also grants the military arbitrary powers to arrest and detain people, including persons "found on any premises or place or in any conveyance" by the "relevant law enforcement or security officer until the completion of the search or investigation under the provisions of this Act.^{"19}
- 12. The Violence Against Persons (Prohibition) (VAPP) Act criminalizes several acts which are harmful and discriminatory towards women and broadens the narrow definition of rape as contained in the Criminal and Penal Codes.
- 13. The Same Sex Marriage (Prohibition) Act 2013 remains in force and provides for a ten-year prison sentence for anyone who supports, meets with, or forms a group advocating for the human rights for LGBTI people. It criminalizes freedom of speech, association, and assembly and the activities of LGBTI organizations.²⁰

THE HUMAN RIGHTS SITUATION ON THE GROUND

Freedom of expression and peaceful assembly

- 14. Journalists and digital activists continue to face harassment, threats, and attacks from state authorities for peacefully expressing critical opinions. During the 2023 general elections, 42 journalists suffered attacks and harassment, including being beaten and denied access to information, while covering the elections.²¹
- 15. In March 2023, the National Broadcasting Commission (NBC) sanctioned 25 broadcast stations over the coverage of the 2023 elections.²² On 10 May 2023, a Federal High Court in Abuja declared the ban unlawful.²³
- 16. On 27 July 2022, the Non-Governmental Organization Regulations Bill, which seeks to gag civil society organizations, was reintroduced in the House of Representatives.²⁴
- 17. Individuals who freely express their opinions continue to face repression. On 5 April 2022 in Kano, Mubarak Bala, president of the Humanist Association of Nigeria, was sentenced to 24 years' imprisonment over Facebook posts which allegedly insulted Prophet Muhammad.²⁵
- 18. On 4 June 2021, the Nigerian authorities announced a ban on Twitter in Nigeria.²⁶ The ban was lifted after seven months on 13 January 2022. On 14 July 2022, the ECOWAS Court declared the ban unlawful.²⁷
- 19. On 20 October 2020, the Nigerian army and police killed at least 12 peaceful protesters at Lekki toll gate and Alausa, Lagos, where thousands were protesting police brutality as part of the #EndSARS movement.²⁸ More than 40 #EndSARS protesters arrested in October 2020 remain in prison detention.²⁹

Forced evictions

20. Forced evictions have continued unabated in Nigeria since the last review, without adequate notice or consultation. In October 2021, Kaduna state authorities demolished over 500 structures in Graceland community, Zaria. In February 2022, Rivers state authorities forcibly evicted 60,000 residents of waterfront communities from their homes in Diobu, Port Harcourt.³⁰ In the Federal Capital Territory (FCT), Durumi 3, Iddo Sarki, NEPA Junction Gudu, Mpape, Katampe and Lugbe, communities have been subjected to forced evictions.³¹



Violence against women and girls

21. Despite the FCT and 35 states having domesticated the VAPP Act,³² violence against women and girls remains pervasive. ³³ Since the last review, there has been an upsurge in reports of rape across Nigeria. The Nigeria police recorded 717 incidents of rape between January and May 2020.³⁴ In its 2020 annual report, the National Human Rights Commission noted having received 11,200 reported cases of rape.³⁵

Armed conflict

- 22. Nigeria has failed in its responsibility to protect people from various abuses committed by Boko Haram and Islamic States West African Province (ISWAP) as well as unknown gunmen³⁶; who killed at least 6,907 people, abducted 6,157, and forcibly transferred or internally displaced at least 2,000 in 2022.³⁷ The authorities are yet to rescue many women and children in captivity, while many schools remain closed.³⁸ The rampage and killings in Southern Kaduna have continued to escalate.³⁹
- 23. The Nigerian military counter-insurgency operations in Northeast Nigeria led to gross human rights violations and crimes under international law including extrajudicial executions, enforced disappearances, arbitrary arrests, and incommunicado detention.⁴⁰ Since July 2019, the Nigerian air force has carried out at least 17 fatal airstrikes on civilian settlements.⁴¹ Also, since 2021, security forces have committed several human rights violations in their response to spiraling violence in southeast Nigeria.⁴²

Communal violence

24. Violent clashes between members of farmer communities and members of herder communities in parts of Nigeria over access to water, land, and pasture have remained unaddressed.⁴³ On 7 April 2023, at least 43 persons were killed by armed invaders at the LGEA Primary School IDP camp, Benue state.⁴⁴ On 12 May 2023, armed gunmen killed at least seven people and burned at least 50 houses in Takalafiya Mada, Nasarawa state. In Benue state, herder–farmer conflicts remain common, leading to the killing of thousands of people.⁴⁵

Rights of LGBTI people


- 25. Human rights violations continue to be committed against people suspected of engaging in same-sex relations or for having a non-conventional gender identity, including arrest, public shaming, extortion, and discrimination.
- 26. In December 2018, 47 men faced criminal charges in Lagos for their expression of affection in public with members of the same sex. In October, a court in Lagos dismissed the case against them.⁴⁶ In June 2022, three gay men; Abdullahi Beti, Kamilu Ya'u, and Mallam Haruna were detained under the Same Sex Marriage (Prohibition) Act 2013. A Sharia Court in Ningi, Bauchi state sentenced them to death.⁴⁷

The impact of the oil industry on human rights

27. Despite supporting recommendation to take effective measures to assist the communities suffering from environmental damage across the Niger Delta due to oil spills,⁴⁸ the Niger Delta region continues to suffer from an epidemic of oil spills which have devasting impacts on the human rights and livelihoods of the communities.⁴⁹ In 2021, Shell announced its plans to sell its onshore oilfields and assets in the Niger Delta after 60 years of highly profitable operations in the area. Shell has not explained how it plans to address the widespread and systemic pollution of Nigerian communities linked to its operations.⁵⁰

Enforced disappearances, unlawful killings, and unlawful detention

28. Several men were forcibly disappeared by the authorities in response to the activities of the Indigenous People of Biafra in southeast Nigeria. Sunday Nwafor, Uzonwanne Ejiofor and Wilfred Dike, who had been secretly detained by the military without charge since 27 February 2020, were released on 14 September 2022 without trial.⁵¹ Government critic Abubakar Idris remained missing since his abduction by suspected state agents in 2019.⁵²



30. Nigerian prisons remain congested, with about 69% of inmates awaiting trial - some for over five years.⁵⁵ On 2 December 2021, five awaiting trial inmates were killed, and seven others injured after being electrocuted at the Ikoyi Correctional Centre Lagos.⁵⁶

Death penalty

31. Although no judicial executions are known to have been carried out since 23 December 2016, authorities in Nigeria are resorting to imposing the death penalty as a quick fix to insecurity and violent crime. Twenty-six states have laws prescribing the death penalty for kidnapping and other crimes. As of 8 May 2023, 3,322 people were known to be under sentence of death.⁵⁷ In August 2022, the Court of Appeal ordered the retrial of musician Aminu Yahaya-Sharif, who was sentenced to death for blasphemy in 2020.⁵⁸

RECOMMENDATIONS FOR ACTION BY THE STATE UNDER REVIEW

Amnesty International calls on the government of Nigeria to:

The national human rights framework

- 32. Amend the Constitution to guarantee economic, social and cultural rights as human rights and to make them enforceable in court.
- 33. Bring the Terrorism Prevention Act into line with international law, including by providing that an individual may only be arrested on reasonable suspicion of having committed a criminal offence.
- 34. Amend Section 33(2) of the Constitution and Police Force Order 237 to ensure that these only allow the use of lethal force to protect life as permitted by international human rights law.
- 35. Speedily enact the Gender and Equal Opportunities Bill.
- 36. Ensure the Violence Against Persons Prohibition Act is swiftly domesticated in the two remaining states and ensure its effective implementation across Nigeria.
- 37. Ensure the Child Rights Act is immediately domesticated in the two remaining states and ensure its effective implementation across Nigeria and take steps to prevent attacks on schools by providing perimeter fencing and adequate security in all school premises.

Freedom of expression and peaceful assembly

- 38. Withdraw the Non-Governmental Organizations Regulatory Commission of Nigeria (Establishment) Bill.
- 39. Release all those detained for peacefully expressing their opinions and ensure access of victims and their families to effective remedies, including adequate compensation, restitution, and guarantee of non-repetition.
- 40. End all forms of harassment and intimidation of journalists and human right defenders, and the use of fear to deter people from using social media platforms to express their opinions.
- 41. Ensure that all law enforcement agencies revise their policies and practices for the policing of protests, responsibly with international human rights standards, and effectively investigate all allegations of human rights

violations by police officials during protests, bring all those found responsible to account, and provide redress to victims.

Forced Evictions

- 42. Establish a moratorium on mass evictions until adequate legal and procedural safeguards are in place to ensure that all evictions comply with international human rights standards, including the UN Basic Principles and Guidelines on Development-Based Evictions and Displacement.
- 43. Provide effective remedies, including adequate alternative housing and compensation for any loss or damage to property for persons who have been victims of forced eviction.

Armed conflict

- 44. Implement safeguards against human rights violations by the security forces, including arbitrary arrest, incommunicado and arbitrary detentions, rape and other forms of torture and other ill-treatment, enforced disappearance, and extrajudicial executions and other unlawful killings, and air strikes on civilians.
- 45. Initiate independent and effective investigations into all allegations of war crimes and possible crimes against humanity committed by the Nigerian military, Boko Haram, bandits and unknown gunmen with the aim of bringing suspects to justice in fair trials.

Communal violence

- 46. Protect ordinary people against attacks by rival communities, including by taking all necessary legal measures to guarantee their safety and security and protect their life and property.
- 47. Initiate an independent, impartial, and effective investigation into the conflicts between farmers and herders with the aim of bringing suspects to justice in fair trials and providing a remedy to the victims.

Rights of LGBTI people

48. Repeal the Same Sex Marriage (Prohibition) Act, 2013 and any other law that discriminates on the basis of sexual orientation or gender identity.

The impact of the oil industry on human rights

49. Ensure effective clean-up of the oil pollution and adequate compensation for those whose livelihoods have been devastated and whose health has been harmed.

Enforced disappearance, extrajudicial executions and unlawful detention.

- 50. Ensure that enforced disappearance constitutes a criminal offence in line with Nigeria's obligations under the Convention for the Protection of All Persons from Enforced Disappearance.
- 51. Ensure that all detainees suspected of a crime are brought before a court of law within 24 or 48 hours where so required by the Constitution, and in all cases within no more than a few days as required under Article 9(3) of the International Covenant on Civil and Political Rights, as interpreted by the Human Rights Committee.

The death penalty

- 52. Abolish the death penalty for all crimes, and in the meantime:
- 53. Establish a moratorium on all executions with a view to abolishing the death penalty for all crimes.



- 54. Commute all death sentences to terms of imprisonment.
- 55. Repeal all provisions that provide for mandatory death sentences, which are inconsistent with international human rights law.
- 56. Ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights and amend section 33(1) of the Constitution to prohibit the death penalty.
