This list gives details of 455 people reported to have died in custody of police and security forces as a result of torture or ill-treatment between 1 January 1985 and 1 May 1992. It is a full and updated version of data on 415 such deaths produced in summary form in Appendix I to Amnesty International's report <u>India: Torture, Rape and Deaths in Custody</u> (ASA 20/06/92).
