UA 211/86 Fear of Torture/Legal Concern 25 July 1986

EL SALVADOR: Joaquin RODRIGUEZ

Amnesty International is concerned at the reported abduction and shooting of Joaquin Rodriguez, a 34-year-old refugee worker with the Catholic Archdiocese. He was abducted on 24 July 1986 as he was leaving the church-run Domos Maria Refugee Camp, in the Colonia Mexicanos, on the outskirts of San Salvador, El Salvador.

Joaquin Rodriguez was leaving the camp, having assisted with the transfer there of a number of displaced persons, when two large vans with polarized windows drew up alongside him and three armed men in civilian clothes attempted to force him into one of the vans. Joaquin Rodriguez managed to break free from his captors and while attempting to make his escape, was shot and subsequently wounded. Witnesses to the shooting reportedly stated that his abductors then bundled him into the van and made off towards an unknown destination. There are fears for his safety.

## BACKGROUND INFORMATION

Amnesty International is concerned that church workers, including relief and refugee workers, social workers, working with the Archdiocese and human rights workers have been specific targets of harassment and human rights violations, including extrajudicial executions, "disappearances", arbitrary arrests and torture over a period of several years.

On 9 July 1986 Amnesty International launched appeals on behalf of five social workers, including the leader of the Social Secretariat of the Archdiocese of San Salvador, who had received death threats on 28 June 1986 from anonymous telephone callers, stating that they had eight days in which to leave the country or they would be killed. During that weekend, several doctors and medical workers working with displaced people housed by the Catholic Church were also reported to have received death threats.

Included in the appeal also were sisters Gloria aged 22 and Elizabet GALAN GARCIA aged 20, detained on 6 July by members of the Treasury Police. Gloria Galan is a member of the <u>Comité de Madres y Familialres de Presos Politicos</u>, <u>Desaparecidos y Asesinados de El Salvador "Monsenor Oscar Arnulfo Romero" (Co-Madres)</u>, Committee of Mothers and Relatives of Political Prisoners.

- urging that an immediate investigation be launched into the reported shooting and abduction of Joaquin Rodriguez;
- asking that, if held by security forces, his detention be acknowledged, his whereabouts be made known and legal situation clarified;
- asking that, if detained, he be treated humanely and that he receive adequate medical treatment for the injuries sustained during his abduction.

Telegrams and letters should be brief and courteous. Stress that your concern for human rights is not in any way politically partisan. Refer to relevant provisions in international law, such as the United Nations Universal Declaration of Human Rights:

Article 3 — "Everyone has the right to life, liberty and security of person."

Article 9 — "No one shall be subjected to arbitrary arrest, detention or exile."  $\!\!\!\!$ 

 The name of Amnesty International may be used, although letters written in a private or personal capacity may be more effective

Copies of appeals should be sent to relevant diplomatic representatives in your country.

In Urgent Action cases, Amnesty International has to act rapidly to prevent the ill-treatment of prisoners. An appeal is issued when Amnesty International believes it has received reliable and accurate information in such cases. It is not always possible to verify all details independently and in some instances the situation outlined in the appeal may change. Urgent Action participants are always notified of any significant new facts.

Copies of any replies received from government authorities should be sent immediately to your section's Urgent Action coordinator or direct to the Campaign and Membership Department of the International Secretariat. If appropriate, thank the official who has replied and ask to be kept informed about the case.
