# AMNESTY INTERNATIONAL LAUNCHES GLOBAL CAMPAIGN ON THE 50<sup>™</sup> ANNIVERSARY OF THE UN UNIVERSAL DECLARATION OF HUMAN RIGHTS

On 10 December 1997, world leaders including Presidents Scalfaro (Italy), Weizman (Israel), Klestil (Austria), Sampaio (Portugal), Prime Minister Sher Bahadur Deuba of Nepal, Prime Minister Bondevik of Norway, Hans Van Mierlo, Foreign Minister of the Netherlands, 1997 Nobel Peace Prize Winner Jody Williams will be participating in the launch of one of the most ambitious campaigns ever mounted by Amnesty International.

The organization's 1.2 million members will begin a year-long global campaign to celebrate the 50th anniversary of the United Nations Universal Declaration of Human Rights (UDHR), which was adopted in Paris on 10th December 1948. The UDHR, adopted in response to the atrocities committed during the second world war has formed the bedrock of human rights protection for the last 50 years.

The campaign is officially launched in South Africa, with an international media conference at the Holiday Inn Sunnyside Park, 2 York Road, Parktown, Johannesburg at 11am on 9 December (embargoed for 10 December) and a series of public events in Capetown and across the country. Amnesty International sections throughout the world will also be launching the campaign with commemorative events.

On or around the same day, government leaders, members of royal families, Nobel laureates, prominent politicians, celebrities and ordinary people will be signing the same pledges at public activities around the world. Amnesty International will be just one of many non-governmental organizations, who, together with the United Nations will be marking the UDHR's 50th anniversary.

Pierre Sané, the Secretary General of Amnesty International will be in South Africa to launch the campaign. He is available for interviews on the campaign, and in particular to discuss 50 years of human rights in Africa and Amnesty's view on the future for human rights across the continent.

At the same time as the launch of the campaign, Amnesty International will hold its 23rd biennial International Council Meeting in Capetown, the first time it has been held in Africa. This meeting brings together 500 human rights activists from around 80 countries. Many of them have been prisoners of conscience or been harassed and ill-treated by their governments.
