The Supreme State Security Court sentenced three prisoners of conscience to sentences between two and five years. Physician Kamal Labwani was sentenced to three years' imprisonment for inciting armed rebellion.

China - AIDS activist disappeared. Dr Wan Yanhai, an HIV/AIDS activist, reportedly went missing on or around 24 August. Amnesty International fears he has been detained by Chinese police. Dr Wan Yanhai was allegedly under surveillance by plainclothes police as a result of his HIV/AIDS activism and his support for health issues concerning lesbians and gay men and sex workers in China.
