Amnesty International is concerned at reports that Déo Nzeyimana has been tortured by being beaten on the soles of his feet, and that both he and his wife, Georgette Mpawenimana, are being denied food in detention at the *Brigade spéciale de recherche* (BSR), special investigation unit headquarters, in Bujumbura. Amnesty International also considers this to be a form of torture. The organization is investigating reports that Georgette Mpawenimana may also have been beaten.

Georgette Mpawenimana is reported not to have had any food since her arrest on 26 September. Déo Nzeyimana has been denied visits and is also reported not to have been given food since his arrest. The two are apparently being denied food as punishment and to force them to make statements.

Neither Déo Nzeyimana or Georgette Mpawenimana have been charged with a criminal offence. It appears that Georgette Mpawenimana, who works with a Swiss- and French-financed project in Rural Bujumbura province, intended to support small scale economic and reconstruction initiatives in the community, is accused of links with the armed opposition. The basis for this accusation is not known. She was apparently taken to a nearby police station for questioning on 28 September but was returned to the BSR the next day.

Both Georgette Mpawenimana and Déo Nzeyimana are members of the political party, the *Front pour la démocratie au Burundi* (FRODEBU), Front for Democracy in Burundi.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French or your own language (please check with your post office whether there are postal services to Burundi):

- expressing concern at reports that Déo Nzeyimana has been beaten on the soles of his feet and that he and Georgette Mpawenimana are being denied food as a form of torture at the *Brigade spéciale de recherche* (BSR), special investigation unit, Bujumbura.
- asking seeking assurances that these allegations will be investigated and that immediate steps will be taken to ensure that the two will be protected from further ill-treatment or torture, and will be given food immediately;
- calling for the accusations against the detainees to be thoroughly and impartially investigated and for them to be released unless they are to be promptly charged with a recognized criminal offence, with substantive evidence to support the accusations against them;
- calling on the authorities to allow them immediate and continuing access to their families, legal counsel, medical care and representatives of humanitarian and human rights organizations.
