The Ethiopian government has still not replied to Amnesty International's appeals and inquiries about these killings and arbitrary and unlawful detentions by the army in eastern Ethiopia ("Region Five") between 28 January and early February 1994, except to deny the reports in general.

Latest reports indicate that Goyare Aden Olhaye and Deeg Uraag were killed after being held incommunicado for up to three months in military custody. These killings heighten Amnesty International's concern for the safety of all detainees held by the military in Region Five amidst an emerging pattern of human rights violations in the region (see UA 312/94 (AFR 25/18/94, 25 August 1994). There is no further news of Dulane Hassan Gabane, who is still "disappeared" and there are fears for his safety. Ahmed Abdullahi Agooleh has been released.

Amnesty International has learned the names of others reported to have been killed at the time of their arrests in January/February:

- in Galafo, Mohamed Osman Gured (deputy Regional Commissioner), Wasuge Hassan Gurreh and Dubad Osman Kalinle;

- in Godey, Asowe Omar Guhad, Abdi Aden Babas, Abdi Nur Farah and Abdullahi Hassan Hared;

- in Wardheer, Deeg Hassan Sirad, a district commissioner.

The body of Mohamed Hajir, arrested near Degabur in late January, was reportedly found dumped in a well three months after his arrest. The bodies of three other men arrested with him were also later discovered.

Region Five, also known as the Ogaden, and inhabited predominantly by ethnic Somalis, has been a virtually closed military zone for several months.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- calling again for an impartial and independent inquiry into these reports of extrajudicial executions, and in particular the killings of over 80 civilians (of whom Amnesty International has 45 names) by government soldiers in Wardheer on 22 February 1994;

- seeking assurances that those still in detention are being treated humanely in accordance with international standards;

urging the authorities to clarify the whereabouts of Dulane Hassan Gabane;
appealing for the immediate and unconditional release of all detainees held solely for their non-violent opinions.
