Fear for safety / ill-treatment

At least 13 members of an opposition party, *l'Union des forces démocratiques/Ere nouvelle* (UFD/EN), Union of Democratic Forces-New Era have been arrested, and at least five of them appear to be held incommunicado. Amnesty International is concerned for their safety.

Ahmed Ould Lafdal, Mohamed Ould Haroun, Ahmed Ould Wediaa and Ahmed Ould Bah, who are leading opposition politicians and senior members of the UFD/EN, were arrested by the police in Nouakchott, the capital, on 9 November. Reports suggest that they have been held incommunicado since. Sidi Ould Salem, another senior UFD/EN member, was arrested in Nouakchott on 11 November and is also reported to be held incommunicado. It is not known where any of the five men are detained.

It has also been reported that 8 women, including Marième Mint Saiga and Benina Mint Chedad, who are active members of the UFD/EN, were arrested by the police in Nouakchott on 13 November. It is not known where they are held.

Amnesty International fears the detainees might be ill-treated in custody. In the past few months, the Mauritanian security forces have arbitrarily arrested and detained scores of opposition supporters. Some were severely beaten at the time of arrest and while in custody.

The latest arrests follow the government banning of the UFD/EN on 28 October, and appear to aim at silencing the UFD/EN and at preventing its members from demonstrating.

BACKGROUND INFORMATION

Since the beginning of October, political tension has increased in Mauritania as a result of the renewed fighting in Israel and the Occupied Territories. The authorities have forbidden and violently suppressed several opposition demonstrations organized to protest against a 1999 government decision to establish diplomatic links with Israel. The situation worsened after the government decided to dissolve the UFD/EN on 28 October, accusing the party of "inciting violence". The accusations have been rejected by the UFD/EN, whose Secretary General, Ahmed Ould Daddah, described the government's decision as void and illegitimate.

Opposition parties, human rights organizations and the media operate with great difficulty in Mauritania amidst a climate of increasing political repression and arbitrary arrests. Press freedom is severely curtailed and human rights organizations are forced to operate without government authorization, leaving human rights defenders liable to prosecution and imprisonment under Mauritanian law for "administer[ing] associations which are functioning without authorization".

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in French or your own language:

- urging the authorities to guarantee the safety of the thirteen UDF/EN members detained since 9 November, and to ensure that they are treated in accordance with international standards;
- urging that they are given immediate access to their families, lawyers and medical care as appropriate;
- expressing concern that the ${\tt UFD/EN}$ members have been arrested solely because of their political activities;
- urging the authorities to release them immediately and unconditionally unless they are to be charged with a recognizably criminal offence.
