Eleven people arrested in connection with the April 1990 coup attempt have reportedly been put through three secret trials before a government controlled tribunal in an apparent attempt to ensure that they are convicted and sentenced to death. Amnesty International fears that executions may be imminent and urges the government not to carry out any executions and to release those prisoners who were acquitted in previous trials before the Special Military Tribunal.

The 11 men named above, who include two civilians, have reportedly been sentenced either to death or to life imprisonment in their third trial before a Special Military Tribunal. They were charged with treason, a capital offence, or concealment of treason, punishable by life imprisonment. Details of their convictions are not known, nor is it clear when the first and second trials took place but they apparently resulted in acquittals. As with similar trials of alleged coup plotters in 1990, it appears that the government ordered their retrial in an attempt to ensure convictions and death sentences. Amnesty International is concerned that the reason for the retrials was political and that the trials were grossly unfair.

Amnesty International earlier expressed concern that Charles and David Mukoro, relatives of an armed forces officer suspected of involvement in the coup attempt who escaped arrest, were among the 11 on trial. In fact, it appears that David Mukoro is an armed forces officer and is among the 11, but that Charles Mukoro may still be detained without charge or trial, as are other relatives of people suspected of organizing the coup attempt (see <u>Nigeria:</u> Detention of hostages, AFR 44/11/91, 8 October 1991).

FURTHER RECOMMENDED ACTION: Telegrams\telexex\faxes\express and airmail letters:

- expressing concern that the Nigerian government has apparently put defendants through three secret trials before a government controlled tribunal

in an attempt to ensure convictions and death sentences;

- requesting information about the 11 prisoners and the three trials they are alleged to have faced before the Special Military Tribunal;

- urging the government not to carry out any executions and to release those prisoners who were acquitted in previous trials before the Special Military Tribunal.
