UA 09/94 Attempted extrajudicial execution / fear  
for safety

RWANDA André KATABARWA, human rights activist  
and members of his household

Amnesty International fears for the safety of André Katarbarwa and members of his household after what appears to have been an attempt on the human rights activist's life. On 11 January 1994 an unidentified man threw a grenade at André Katarbarwa as he was coming out of his home in Kiyovu, a suburb of Rwanda's capital, Kigali. André Katarbarwa and his day-watchman were both slightly injured in the attack.

Eyewitnesses saw a man on a motorcycle without registration plates outside André Katarbarwa's house, apparently waiting for him to come out. A marked vehicle of the Rwandese Gendarmerie (paramilitary police) was also seen patrolling the area, but failed to arrest the man after he had thrown the grenade. The gendarmes reportedly waited until the attacker had fled before leaving the area. Unofficial sources in Kigali say that the attacker could have been a member of the security forces, or at least acting with their approval. The attack is typical of a series which has occurred over the last year, targeting known human rights activists, including Marie-Alphonse Nkubito, a state prosecutor (see UA 423/93, AFR 47/10/93, 1 December 1993).

André Katarbarwa works for the *Association des volontaires de la paix* (AVP), one of Rwanda's non-governmental human rights organizations. He is a former government minister and Ambassador to Italy.

#### BACKGROUND INFORMATION

Several human rights activists, as well as members of political parties opposed to President Habyarimana have been threatened or attacked either by armed Hutu gangs or by members of the security forces (often in plainclothes) since early 1993.

Members of the minority Tutsi ethnic group and those belonging to the majority Hutu ethnic group known or thought to oppose President Juvénal Habyarimana, live with the daily threat of death, injury and the looting and destruction of their property. Over 300 people are known to have been killed by the Rwandese security forces and hundreds of others are said to have been murdered by armed gangs since the beginning of 1993.

Since war broke out in Rwanda in 1990 between Hutu-dominated government forces and rebels of the Tutsi-dominated *Rwandese Patriotic Front* (RPF), more than 2,300 people, mostly of the Tutsi ethnic group have reportedly been killed by security forces and Hutu gangs. Despite the signing of a Peace Accord in August 1993, insecurity and tension in the country has continued, partly due

to the delay in the setting up of a transitional government and the late arrival of UN peace-keeping troops. Several non-governmental organizations in Rwanda, such as the AVP, have documented and published information highly critical of the role played by government and security forces in the violation of human rights during and after the war with the RPF.

**RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in French or English or in your own language:**

- expressing concern at reports that André Katararwa and his home have been subjected to a grenade attack by a person believed by some to be a member of the security forces;
- urging the authorities to take immediate measures to protect André Katararwa and his family from any further attacks;
- asking the authorities to set up an independent and impartial inquiry into the attack with a view to bringing those responsible to justice;
- urging the government to publicly condemn such attacks and take steps to prevent their recurrence.
