Amnesty International is gravely concerned at unconfirmed reports in the government-owned newspaper New Vision that some, possibly all, of the prisoners named above have been executed. Prison officials in Kampala, meanwhile, deny any executions have occurred. While Amnesty International is attempting to verify its information, immediate action is required to stay any remaining executions.

Amnesty International also continues to be gravely concerned not only for the 28 men, but also the implications a resumption of executions will have for the more than 1,000 prisoners currently on death row in Uganda, not all of whom have completed their appeals.

Twenty-six of those due to be hanged have been convicted of murder, the other two of aggravated robbery. One man, Haji Musa Ssebirumbi, was found guilty of murder in 1989 and lost his appeal in June 1992. He has been on death row since then. Details of the others' cases are not known, but it is believed that many of them were convicted of murder over 10 years ago. All were reportedly due to die at Luzira Prison in Kampala at 7.30pm local time on 30 April 1999.

The Advisory Committee on the Prerogative of Mercy reportedly recommended confirmation of the prisoners' death sentences after the Supreme Court denied their appeals. This committee advises President Museveni on which death sentences he should commute or confirm. The President still has the option to override the committee, exercise executive clemency and spare the men's lives.

Amnesty International is universally opposed to the death penalty, and is deeply concerned by the possibility of the resumption of executions in Uganda.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- expressing concern at reports that Uganda may have executed some or all of the prisoners named above;
- expressing dismay at the reported resumption of execution procedures in Uganda;
- expressing sympathy for the victims of violent crime and their families, but stating opposition to the use of the death penalty in all cases, on the grounds that it is a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment or punishment, as proclaimed in the Universal Declaration of Human Rights;
- appealing for President Yoweri Museveni to exercise clemency and to commute these death sentences, and all other death sentences that come before him;

- appealing for a public moratorium on executions in Uganda and urging the authorities to consider abolishing capital punishment completely;

- urging that the Advisory Committee on the Prerogative of Mercy commutes all death sentence it reviews.
