Concerns remain for the safety of Gustavo Melmann, members of his family and family friends as they continue to be subjected to harassment and intimidation following the conviction of three policemen for the murder of Gustavo Melmann's daughter Natalia. The family have received repeated death threats throughout the murder investigation, which is ongoing.

On 30 September 2002 three policemen from the Buenos Aires police force were sentenced to life imprisonment in connection with the rape and murder of Natalia Melmann in Miramar, Buenos Aires province. While the family continues to press for the trial of two other men allegedly involved in the murder, they suffer further threats of violence.

In November 2002 Natalia's grave was desecrated with offensive material, causing great distress to the whole family. Subsequently, a close friend of the family was reportedly threatened with physical violence in the street by the wife of one of the jailed policemen. The Melmann family were also mentioned in her threats. A local radio station received a note that called Gustavo Melmann "un judío de mierda ("a Jewish piece of shit"). Mr Melmann's religion has been a frequent subject of abuse.

Although the authorities are now investigating the threats, the family have filed several judicial complaints as the threats continue. 4 February 2003 will be the second anniversary of Natalia's death and the family continue to press for the trial of the two other men allegedly involved in her murder.

FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing your concern at the continued threats and intimidation received by the Melmann family and their friends;
- asking for assurances that the authorities will take all necessary steps to protect the threatened parties and effectively guarantee their safety;
- calling for an immediate, independent and thorough investigation into these threats, for the results to be made public and those responsible brought to justice:
