**Death threats: Osvaldo Rioja and Jhenny Osinaga, TV journalists
Gloria Eyzaguirre and Jaime Buitrago, newspaper journalists**

All those arrested after anti-government protests which led the government to declare a "state of siege" have now been released, apparently without charge. However, Amnesty International remains concerned for the safety of the journalists named above, who have received death threats believed to be connected with their coverage of the demonstrations and reports into corruption.

Journalists Osvaldo Rioja and Jhenny Osinaga received anonymous telephone death threats after their TV network, *Periodistas Asociados Televisión* (PAT), Associated Journalists Television, broadcast footage of an army officer firing at the crowd during a demonstration in Cochabamba on 8 April.

The national newspaper *Presencia* has been publishing reports into government corruption. On 13 April News Editor (*Jefa de Información*) Gloria Eyzaguirre and reporter Jaime Buitrago received anonymous death threats against themselves and their families. The same day an anonymous caller told the editor's office that a bomb had been planted in the building. Both these threats have been publicly denounced.

Investigations have reportedly begun into the killing of five people, including an army officer, during the demonstrations, which took place in La Paz Department and the cities of La Paz and Cochabamba. The army has reportedly begun an investigation into why an army officer in civilian clothes was shooting at the crowd in Cochabamba on 8 April, when 17-year-old Hugo Daza was shot dead. Amnesty International will be monitoring these investigations closely.

The "state of siege" was lifted on 20 April after the government reached an agreement with peasant and trade union organisations.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

- expressing concern at the reported death threats against journalists at PAT and *Presencia*;
- asking the authorities to guarantee their safety;
- urging an immediate, independent and exhaustive investigation into these death threats, and asking for information on any investigation already underway.

APPEALS TO: Please note that the Bolivian cabinet resigned on 24 April. A new cabinet will be appointed shortly. For the time being please send your appeals without the minister's name.
