BRAZIL: Luis Inacio DA SILVA and 10 other trade unionists

On 25 February 1981 a São Paulo military court tried Luis Inacio da Silva (known as "Lula") and 12 other members of the metal workers' union on charges under the Law of National Security. The charges related to a six-week strike by metal workers in São Paulo in 1980. Amnesty International expressed concern that although neither the defendants nor their lawyers were present in the court, the judge proceeded to try them *in absentia*, which is contrary to the military penal code. The defendants and their lawyers' absence from the court was in protest against the severe restrictions imposed on entry to the court. Lula and 10 of the trade unionists were sentenced to terms of imprisonment; two others were acquitted.

The lawyers are now appealing to the Superior Military Tribunal (STM) that the trial be annulled because of the irregularities in the earlier procedures. The appeal will be heard in the STM in Brasilia at 1.00 pm on 2 September 1981. There are fears that the sentences of some of the accused may be upheld.

Amnesty International considers all these trade unionists to be prisoners of conscience.

Luis Inacio da Silva: known as "Lula", was elected first secretary of the São Bernardo union in 1972. He was elected the union's President in 1975 and 1978. He is the national president of the *Partido dos Trabalhadores* (PT - Workers' Party). He is married with three children. He was sentenced to three and a half years' imprisonment.

Djalmo de Souza Bom: born in Minas Gerais in 1939. He first worked as a metal worker in 1962 and joined the metal workers' union in 1965. In 1975 he was elected to the union's finance committee and became treasurer. He is now a member of the State Executive Committee of the PT. He is married with 2 children. He is a quality controller but is currently unemployed. He was sentenced to three and a half years' imprisonment.

Juraci Batista Magalhães; aged 31, born in Bahia. He arrived in São Paulo in 1969. He trained as a carpenter and joined Volkswagen in 1972. In 1972 he joined the metal workers' union and in 1978 became shop steward for the Mercedes Benz plant. He is a machine operator but is now unemployed. He was sentenced to two and a half years' imprisonment.

Enilson Simões de Moura: known as "Alemão", aged 31 and from Minas Gerais. In 1972 he came to São Paulo where he worked as a mechanic. In 1975 he joined Volkswagen as a quality controller. In 1979 and 1980 he was a member of the Wage Committee of the São Bernardo union and although he was not a shop steward for the union he became a well-known leader, particularly after the arrest of the union's executive in 1980. He is a member of the labour department of the Partido do Movimento Democratico Brasileiro (PMBD - Party of the Democratic

Brazilian Movement). He is married with two children. He was sentenced to three and a half years' imprisonment.

Manoel Anisio Gomes: born in Pernambuco. A metal worker in São Paulo since 1964, he joined the union in 1976. He was a member of the factory commission at Scania but was sacked in 1977. He is a member of the Municipal Executive Committee of the PT. He is married with four children. He is now unemployed. He was sentenced to two and a half years' imprisonment.

Gilson Luiz Correia de Menezes: born in Bahia in 1949. He joined the union in 1973. In 1976 he was a member of the Scania factory commission. He is currently unemployed and is in charge of the strike fund. He is a member of the Municipal Committee of the PT in Diadema. He is married with three children. He was sentenced to two and a half years' imprisonment.

Nelson Campagnolo; born in the interior of São Paulo state. In 1963 he went to São Paulo and a year later joined the union. In 1972 he became a member of the union executive, a post he held until he lost his right to hold public office. After the imprisonment of the other union leaders he led strike meetings. He is a member of the PT. Aged 39, he is married with two children. He is a welder but is now unemployed. He was sentenced to two years' imprisonment.

Osmar dos Santos Mendonça: from Minas Gerais. He went to São Paulo to study to become a mechanic. In 1976 he joined the union. After the arrest of the leaders of the union in 1980 he was one of the main organizers until his arrest in São Bernardo. He is a member of the state committee of the PT. Now aged 30, he is married with one child. He is a boiler-maker. He was sentenced to two and a half years' imprisonment.

Jose Maria de Almeida: aged 23 and born in the interior of São Paulo state. He joined the union in 1976. In 1977 he was arrested and tortured for distributing pamphlets calling for a 1 May meeting. He was tried and acquitted. He was arrested again in 1978 for participating in a meeting of the Socialist Convergence. He is a member of the Municipal Executive Committee of the PT in Santo Andre. He is unmarried. He was sentenced to two and a half years' imprisonment.

Rubens Teodoro de Arruda: born in the interior of São Paulo state. Since 1965 he has held a number of important trade union positions including that of vice-president. He is a member of the PT and is 42 years old, married with three children. He lost his job as a production supervisor but has bought a small grocery shop. He was sentenced to three and a half years' imprisonment.

Wagner Lino Alves: born in São Paulo. In 1978 he began to work in São Bernardo. In 1980 he was part of the negotiating team with the management of Termomecanica. He is the treasurer of the strike fund in São Bernardo. He is a member of the PT. He is aged 33 and unmarried. He is a lathe operator. He was sentenced to two years' imprisonment.

Jose Timoteo da Silva: became an active union member in Santo Andre in early 1970. Although he has never held any official post, he is highly regarded among trade unionists. Before 1980 he had been arrested on at least eight occasions. He is a lathe operator, a member of PMDB and is married with one child. He was acquitted.

Jose Cicotti: born in the interior of São Paulo state, aged 44. In 1963 he went to Santo Andre and started work in the Pirelli factory. In 1972 he was elected to the financial committee of the metal workers' union. In 1975 he

became an executive member until he lost his right to hold public office. He is a member of the Municipal Committee of the PT in Santo Andre. He is currently unemployed and is married with four children. He was acquitted.

Amnesty International is concerned that these trade unionists were sentenced under the Law of National Security for peaceful and legitimate trade union activities. There is also concern that the trial proceedings were conducted in the absence of the defendants and their lawyers in contravention of Article 431, paragraph 4, of the Codigo Processo Penal Militar, and that unusually severe restrictions were imposed by the military judge prohibiting the attendance of suitably qualified observers, which give rise to anxiety about whether the defendants received a fair and just trial.

RECOMMENDED ACTION: PLEASE ORGANIZE ABOUT 20 APPEALS

Telegrams expressing concern about the manner in which the trial of these trade unionists was conducted in February 1981 and urging that the appeal hearing of these cases by the Supreme Military Tribunal will result in a just decision which will reassure public opinion that the right to a fair trial is being respected in Brazil.
