Amnesty International is seriously concerned for the safety of Anderson Pereira dos Santos, Thiago Passos Ferreira and Paulo Roberto da Silva, who "disappeared" on 17 February 1999 after they were arrested by military police.

The three were leaving a carnival party in the early hours of the morning in São Vicente, a town on the coast of São Paulo state, when they were stopped by the Military Police Mounted Regiment (Regimento de Cavalaria). Witnesses reportedly saw the police kick and beat the three young men before taking them away in a police car. Bloodstains found inside the car are now undergoing forensic tests.

Both the military and civil police are investigating the alleged "disappearances". Seven military police have now been arrested, four of whom have been identified by witnesses. A public prosecutor is accompanying the military police investigation at the request of the São Paulo state police ombudsman's office.

BACKGROUND INFORMATION

The number of civilians killed by the military and civil police in São Paulo state rose from 368 in 1996, and 405 in 1997, to 525 in 1998, according to the São Paulo state police ombudsman. Military police were responsible for around 87% of these deaths. Police claim that 80% of these shootings result from suspects resisting arrest. The majority had no criminal record.

Most of these killings, even if the subject of an internal investigation by military police, do not result in criminal prosecution.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Portuguese or your own language:

- expressing extreme concern at the news that Anderson Pereira dos Santos, Thiago Passos Ferreira and Paulo Roberto da Silva have not been seen since being arrested and beaten up by Military Police on 17 February 1999 in São Vicente;
- voicing concern for their safety;
- urging the authorities to make every effort to find them;
- asking the authorities to carry out a full, impartial and independent investigation into this case, that they make the results public and that they bring those responsible to justice.
