Amnesty International is alarmed at reports of the existence of a "hit-list" of some 40 people in the town of Xinguara, in the state of Pará. It is reported that six people whose names appear on the list are already dead, two have been the victims of attack, and others, fearing for their lives, have fled the area.

According to evidence given by *pistoleiros* (gunmen) already charged in connection with related incidents, those named on the list have been singled out to be killed because of their links with *posseiros* (peasant farmers) involved in local land conflicts; Father Ricardo Rezende, Brother Henri des Rosiers, Father Benedito Rodrigues Costa and Elpídio Pereira da Silva are believed to be among the names on that list. The names of various small businessmen and property owners in Xinguara are also alleged to appear on the list.

A pistoleiro currently being held in Paraúna, Goias State, accused of attempted murder also confessed in a statement given to local police on 21 September 1994 that he had been contracted by someone to kill "a certain Father Ricardo Rezende".

On 23 September, a man telephoned Father Ricardo's house to say, "Tell Father Ricardo that his days are numbered and tell those who work with him to watch out too" ("Para avisar ao padre Ricardo que seus dias estão contados e para avisar tambem o pessoal que trabalha com ele"].

BACKGROUND INFORMATION

In the past, church figures and those seen to be supporting or representing the interests of peasant families in southern Pará in the context of land disputes with local landowners, have been the targets of death threats, assaults, abductions and killing. While Amnesty International takes no position on competing claims in this type of conflict, it is concerned at the impunity with which gunmen, allegedly acting on behalf of landowners, and with the apparent tolerance of local authorities, continue to intimidate and carry out violent attacks on the peasant communities.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Portuguese or in your own language:

- calling for an investigation to be carried out without delay into the alleged "death-list" naming some 40 people in Xinguara;
- urging that immediate action be taken to ensure the safety of Father Ricardo Rezende, Brother Henri des Rosiers, Father Benedito Rodrigues Costa and Elpídio Pereira da Silva and their colleagues;
- demanding that those responsible for the above threats and the apparent persecution of people involved in land conflicts be swiftly identified and brought to justice.
