On 12 April 1998 the body of Carlos Enrique Maso Vargas was found murdered. Fears for the safety of other members of the displaced community of La Balsita, who have taken refuge in Dabeiba, amid repeated death threats from local paramilitary forces, are now heightened.

On 11 April Carlos Enrique Maso Vargas was abducted by paramilitary gunmen who dragged him from a bus, loudly accusing him of being a guerrilla (member of the armed opposition). They informed his brother, Jhon Fredy Vargas, with whom he was travelling that they would not take him as well because his five-year-old son was with him. The bus had just departed Dabeiba.

There are also fears for the safety of Alvaro Gaviria, also a displaced person residing in Dabeiba, who was recently threatened by paramilitary gunmen and accused of being a guerrilla. Those accused of being guerrilla sympathizers or auxiliaries are often the victim of "disappearances" and extrajudicial executions.

In the last 15 days paramilitary forces which control check points into Dabeiba have reportedly limited the quantity of food entering the town and have made threats to local residents.

Reports confirm that, in spite of repeated denunciations to the authorities by local people, paramilitary forces continue to operate with total freedom in the vicinity. Paramilitary groups also operate openly in the presence of civil, police and military authorities. Known members of paramilitary groups have been seen conversing with members of the government-licenced rural vigilante associations, formerly known as CONVIVIR, which were established to provide local intelligence information to the security services but, in reality, works in collaboration with paramilitary groups.

Over the past year thousands of peasant farmers from various communities in the Urabá region have fled their homes as a result of paramilitary offensives. Others have fled as a result of threats from guerilla forces against those they consider to be army or paramilitary collaborators. The community of La Balsita fled their homes to seek refuge in Dabeiba after paramilitary groups killed several community members in November 1997.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/ e-mails/faxes/express/airmail letters in Spanish or in your own language:

- expressing concern for the physical safety of Jhon Fredy Vargas and Alvaro Gaviria and other members of the displaced community of la Balsita who have sought refuge in the municipal capital of Dabeiba;
- calling on the authorities to take all measures deemed appropriated by the community to guarantee their safety;

- calling for a full and impartial investigation into the abduction and killing of Carlos Enrique Maso Vargas, for the results to be made public and for those responsible to be brought to justice;
- urging the authorities to take immediate action to dismantle paramilitary groups, in line with stated government commitments.
