COLOMBIA

Civilian inhabitants of rural communities of the Alto and Bajo Naya regions and communities of the Yurumaguí River, Valle del Cauca and Cauca Department

Amnesty International is seriously concerned for the safety of the Afro-Colombian, indigenous and peasant farmer communities of the Naya River that borders the departments of Valle del Cauca and Cauca and the Yurumanguí River, following reports of an imminent launch of attacks in the area.

Paramilitaries based in the Valle del Cauca and Cauca Departments are reportedly preparing to attack guerrilla forces in the same area. In recent months, there has been an enormous increase in action by army-backed paramilitary groups in some municipalities of these departments. Paramilitary threats against the civilian population there have also reportedly increased.

Amnesty International fears that, as on previous occasions, civilian communities in conflict zones will be labelled as guerrilla collaborators by the security forces and their paramilitary allies. Paramilitary forces will then be able to use this as an excuse to commit serious human rights violations such as extrajudicial executions, "disappearances" and death threats.

The threat of attack is apparently so imminent that on 11 July, the Human Rights Ombudsman activated the early alert system (alerta temprana), calling for an immediate response by state authorities. This system is only activated when there is a clear threat to the human rights of the population. To date, Amnesty International has not received any information to indicate that state authorities have taken decisive action to confront paramilitary forces in the area.

On 6 July, on the road between Guachicono and Bolívar, Cauca department, a van carrying some people living in the area was reportedly stopped by army-backed paramilitaries. The passengers were forced to get out of the van and kneel down. The paramilitaries then insulted and ill-treated them as they knelt. Later, paramilitaries threatened them and played a game of "Russian roulette", pointing a gun to their heads. They threatened the people, saying: "Las Autodefensas han llegado", ("The Self-Defence Forces have arrived").

On 10 July, paramilitaries entered other municipalities of the area. In the municipality of La Vega, Cauca department, army-backed paramilitaries with distinctive AUC bracelets wrote graffiti on the walls saying: "Del Urabá al Cauca. Territorio AUC," ("From Urabá to Cauca. AUC Territory") and "Guerrillero que cojamos le volamos la cabeza", ("[If a] guerrilla member [is] caught we will blow his head off").

BACKGROUND INFORMATION

Army-backed paramilitaries have a strong presence in the area and have committed serious human rights violations against the population.

In April 2001, over 30 people were killed by paramilitary forces along the river Naya. The paramilitaries had managed to enter the region en masse despite repeated international alerts of an imminent incursion and despite the heavy military presence around the access points to the Alto Naya where the paramilitary incursion had started.

Since the massacre, many civilians living in the area have fled their homes. At least 3,000 people, the majority of whom are members of the Paez indigenous or Afro-Colombian communities, are believed to have been forcibly displaced

as a result of the paramilitary incursions. Guerrilla forces have also been responsible for threats and killings of civilians they accuse of collaborating with their enemies.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern for the safety of all the communities living along the Naya River, Yurumanguí River and Anchicayá River in Valle del Cauca and Cauca departments;
- expressing concern about the increasing army-backed paramilitary presence in the region and urging the authorities to take action to protect the civilian population;
- reminding the authorities that if they fail protect the civilian population, it will seem that the paramilitaries are operating with the complicity of the security forces;
- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in Valle del Cauca and Cauca departments, urging that the results are made public and those found responsible for supporting and participating in such groups are brought to justice; - urging the authorities to take immediate action to dismantle paramilitary groups, in line with United Nations recommendations.
