Amnesty International is concerned about further detentions and harassment of journalists, some of whom could face imprisonment as prisoners of conscience. Cuban state police recently strengthened their crackdown on independent journalists, issuing warnings that if they did not find work with a state entity, they could be imprisoned for four years on charges of "peligrosidad", "dangerousness". It is the first time that this provision, previously used against some human rights activists, has been used by the Cuban authorities against independent journalists.

Those affected have either been working with the *Buró de Periodistas Independientes de Cuba* (BPIC), Bureau of Independent Journalists of Cuba, which only began its activities on 19 September 1995, or Habana Press, which was set up some months ago.

Most recently, on 12 October María de los Angeles Gutierrez González was summoned by the Havana state police and warned to leave her job with BPIC. She had previously been detained on 4 October for four hours and given the same warning.

On 10 October Hector Peraza Linares was summoned by police in the town of Quivicán, Havana province. He was given 10 days to cease work as an independent journalist with Habana Press and find another job or be tried for "vagrancy" according to the "dangerousness" provision. He had previously been detained on 3 October and given the same warning.

On 7 October Olance Noguera, who works with BPIC, was briefly detained by state police in Cienfuegos province and warned that he had 30 days to find a job with a state entity or else face charges of "dangerousness".

On 3 October Roxana Valdivia was detained by state security in Havana and held for 28 hours with her husband. She was forced to return to her home in Ciego de Avila, province of Cienfuegos. She was warned that she would be jailed again if she returns to Havana and remains in contact with former prisoner of conscience and founder of BPIC, Yndamiro Restano, who was only released from prison in June 1995.

On 15 September Rafael Solano and Yndamiro Restano were interrogated

individually by state security. Their relatives were told that the journalists would be detained again and that the state would not be responsible for any future violent action against them because of the illegal activities they are engaged in.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in Spanish, English or your own language:

expressing concern at reports that those mentioned above have been issued with official warnings of facing charges of "dangerousness" if they continue their work as independent journalists;
urging that members of the BPIC and other freelance journalists be permitted to carry out their legitimate work without such interference from the authorities.
