UA 248/99 Prisoners of conscience/Health concern

CUBA Marcel VALENZUELA SALT, political activist Marlon CABRERA, political activist

Opposition activists Marcel Valenzuela Salt and Marlon Cabrera were arrested on 14 September 1999. Under harsh new legislation aimed at silencing dissent, they could face up to 20 years in prison. Amnesty International is concerned that they have been detained solely for exercising their right to freedom of expression, and considers them prisoners of conscience. They have begun a hunger strike, which they reportedly say they will continue until they are released.

The two men, both members of the illegal opposition group *Hermandad Cívica*, Civic Brotherhood, were arrested, along with five others, in the Butari Park in Havana where they were holding an informal class on civil disobedience. The detainees were all taken to a police station and then to the *Departamento Técnico de Investigaciones (DTI)*, Technical Investigations Department, in Havana. The other five, Oscar Elías Biscet González, Esteban Pérez Castillo, Joaquín Rafael Martínez Rodríguez, Alejandro Chang Castillo and journalist Angel Pablo Polanco, have all now been released, but Marcel Valenzuela Salt and Marlon Cabrera remain in detention at the DTI.

According to Oscar Elías Biscet González, who was arrested with them, Valenzuela and Cabrera shouted "Long live human rights!" as they were arrested and Valenzuela was hit in the face by a plain-clothes policeman. Marcel Valenzuela Salt has been arrested and briefly detained before, in July, August and September 1999.

BACKGROUND INFORMATION

In February 1999 Cuba's National Assembly passed tough new legislation (Law 88) aimed at combating political dissent, called the "Ley de Protección de la Independencia Nacional y la Economía de Cuba", "Law for the Protection of the National Independence and Economy of Cuba". Under this new law, dissidents and journalists deemed to be working against the Cuban state reportedly face up to 20 years' imprisonment. The law calls for seven to 15 years' imprisonment for passing information to the United States that could be used to bolster anti-Cuban measures such as the US economic blockade, rising to 20 years if the information or reproduction of "subversive materials" from the US government, and proposes terms of imprisonment of up to five years for collaborating with radio and TV stations and publications deemed to be assisting US policy.

expressing concern at the recent arrest of Marcel Valenzuela Salt and Marlon Cabrera, and urging that they be immediately and unconditionally released, on the grounds that they are prisoners of conscience detained solely for peacefully attempting to exercise their rights to freedom of expression, association and assembly;
urging that they be granted immediate access to lawyers of their choosing and any necessary medical assistance.
