GUATEMALA: Staff of the Asociación para el Avance de las Ciencias Sociales en Guatemala (AVANCSO), Association for the Advancement of Social Sciences in Guatemala

Amnesty International has learned that army sergeant Noel de Jesús Beteta Alvarez was sentenced on 12 February 1993 to 25 years' imprisonment for the murder of anthropologist and one of the founder members of AVANCSO, Myrna Mack Chang. He was also sentenced to five years' imprisonment for a separate assault on a minor.

Following the recent incidents of intimidation including threats and harassment against staff of AVANCSO and witnesses to the murder of Myrna Mack Chang (See UA 20/93, AMR 34/02/93, 28 January 1993), there are grave fears that, following the sentence, there may be reprisals against the family of Myrna Mack or others associated directly or indirectly with the trial by certain sectors of the security forces.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish, English or your own language:

- noting the recent conviction against army sergeant Noel de Jesús Beteta for the murder of Myrna Mack Chang;
- expressing your hope that this conviction shows the determination of the government not to tolerate any further human rights abuses, no matter who the perpetrators are;
- expressing concern at the recent incidents of intimidation, including threats and harassment of staff of AVANCSO and others involved directly or indirectly in the proceedings;
- asking that these incidents be investigated and that those found responsible be brought to justice;
- asking that immediate measures be taken to protect the physical integrity of all those associated with the trial of Noel de Jesús Beteta including Myrna Mack's family, witnesses to her killing, judicial officials and their families, as well as staff of AVANCSO.
